Contract is expected to start on date of award and end on December 31, 2026.

FINANCIAL IMPACT

The total contract award identified in this report is \$11,161,344 including all applicable taxes and charges. The cost to the City is \$10,051,136 net of HST recoveries.

The engineering estimate for this project is \$9,091,823 net of all taxes and charges.

Funding is included in the 2025 Capital Budget and the 2026-2034 Capital Plan for Toronto Water. Funding details are summarized in Table 1 as follows.
