REASON FOR CONFIDENTIAL INFORMATION

This report deals with personal matters about identifiable individuals who are being considered for appointment to the Board of Directors of TO Live.

SUMMARY

The Civic Appointments Committee will conduct interviews and recommend three candidates to City Council for appointment to the Board of Directors of TO Live.

RECOMMENDATIONS

The City Clerk recommends that:

- 1. The Civic Appointments Committee recommend three candidates to City Council for appointment to the Board of Directors of TO Live, at pleasure of Council, for a term of office ending on May 24, 2029, and until successors are appointed.
- 2. City Council direct that Confidential Attachments 1a, 1b and 2 to 4 remain confidential in their entirety as they relate to personal matters about identifiable individuals being considered for appointment to the Board of Directors of TO Live.

COMMENTS

Composition of the Board of Directors of TO Live

The Board of Directors of TO Live consists of 13 members and is composed of:

- the Mayor or a Council member appointed by the Mayor as the Mayor's designate
- 2 Council members
- 10 public members

There are currently three positions under consideration

There are currently three positions under consideration due to the resignation of Owais Lightwala on January 27, 2025, and the end of terms of Myriam Gafarou and Mustafa Humayun on December 19, 2024, and until successors are appointed.

Public members serve four-year terms

The three successful candidates in this process will be appointed for a term of office ending May 24, 2029, and until successors are appointed.

Public members should meet certain qualifications

Public members of the Board should collectively have significant experience in one or more of the following qualifications:

- current or past leadership role in the performing arts sector or another cultural sector
- community leadership and partnerships
- marketing and sponsorship
- financial management and business strategy
- labour relations

In addition, a youthful perspective, defined as an individual in the 18-30 age range, is a desirable qualification for at least one public member.

There are specific eligibility requirements to serve on the Board of Directors of TO Live

In addition to the general eligibility requirements in the Public Appointments Policy, public members are ineligible for appointment, if any of the following conditions apply to them or their immediate family members if:

- the person is a supplier of goods or services to the City's theatre facilities
- the person has an employment relationship with another performing arts theatre
- the person has an employment, directorship, ownership or controllership interest in an organization that has an interest in performing or producing live performing arts at the City's theatre facilities

Consultation with TO Live

In preparation for the recruitment process, Public Appointments staff consulted with the CEO of TO Live. It was suggested that candidates who identify as Indigenous and/or have experience in financial management would be assets to the board. Economic Development and Culture staff consulted with the Board Chair. It was suggested that candidates with HR expertise, and/or experience managing large community hubs or facilities would be assets to the board.

Public members are volunteers

No remuneration is paid to Board of Directors of TO Live members.

Public release of the names of the recommended candidates

The names of the recommended candidates will be publicly reported once the Civic Appointments Committee forwards its recommendation to City Council.
