REASON FOR CONFIDENTIAL INFORMATION

This report deals with personal matters about identifiable individuals who are being considered for appointment to the Toronto Atmospheric Fund Board.

SUMMARY

This report recommends the appointment of three public members to the Toronto Atmospheric Fund Board.

RECOMMENDATIONS

The City Clerk recommends that:

- 1. The Civic Appointments Committee recommend that City Council appoint the three candidates listed in Confidential Attachment 1 for appointment to the Toronto Atmospheric Fund Board, at pleasure of Council, for a term of office ending on October 11, 2029, and until successors are appointed.
- 2. City Council direct that the balance of Confidential Attachment 1 and Confidential Attachments 2-4 remain confidential in their entirety as they relate to personal matters about identifiable individuals being considered for appointment to the Toronto Atmospheric Fund Board.

COMMENTS

Composition of the Toronto Atmospheric Fund Board

The Toronto Atmospheric Fund Board consists of 11 members including:

- the Mayor or designate,
- · 2 Members of City Council, and
- 8 public members.

Less than a majority of the public members of the board shall be non-Toronto residents that live in the Greater Toronto and Hamilton Area, which includes the City of Toronto, the Regional Municipality of Durham, the Regional Municipality of York, the Regional Municipality of Peel, the Regional Municipality of Halton, and the City of Hamilton.

There are currently three positions under consideration

There are currently three positions under consideration due to the end of terms of Stuart Galloway, Kim Marshall, and Jean Olemou on July 15, 2025, and until successors are appointed.

Term of office

The term of office for public appointees to the Toronto Atmospheric Fund Board is four years. The members appointed will serve a term of office ending October 11, 2029, and until successors are appointed.

Public members should meet specific qualifications

In addition to the general eligibility requirements set out in the Public Appointments Policy, board members should collectively have the following experience or knowledge:

- understanding of TAF's mandate and strategic opportunities for advancing urban low-carbon solutions and improving air quality, including: experience and knowledge of environmental affairs and other benefits associated with emission reduction
- experience with grantmaking, whether through involvement with public or private foundations, community trusts, or government grant programs or via securing and managing grants
- strategic planning expertise, including marketing and knowledge of demographic trends and behavioural science, and stakeholder engagement, which are key to program design, delivery, evaluation and continuous improvement
- other professional expertise including legal and accounting which would support TAF's problem-solving, accountability and good governance

City Council directed the City Clerk to recruit and recommend candidates to the Civic Appointments Committee

The opportunity to join the Toronto Atmospheric Fund Board was posted on BoardShift (Civic Action), Charity Village, Volunteer Toronto, and the Chartered Financial Analyst (CFA) Society Toronto. It was also shared through the Institute of Corporate Directors (ICD), LinkedIn, X, and outreach via the Public Appointments e-update list and internal City partners.

In preparation for the recruitment process, Public Appointments staff consulted with the CEO of Toronto Atmospheric Fund. It was suggested that candidates with experience in finance, a CFA designation, knowledge of grantmaking, and fundraising would be assets to the board. Also highlighted was the need to reflect demographic and geographic diversity on the Toronto Atmospheric Fund Board, including representation of non-Toronto residents.

Staff from the City Clerk's Office and staff from Environment and Climate selected eight candidates for interview based on the City Council approved qualifications and eligibility criteria. Environment and Climate staff were asked to participate on the panel given their subject matter expertise in environmental policy and programs.

The panel consisted of:

- Project Manager, Public Appointments, City Clerk's Office
- Management Consultant, Environment & Climate

The panel determined the final candidates by weighing candidate applications and interview performance.

Staff are recommending three candidates for appointment to the Toronto Atmospheric Fund Board

City Clerk's Office and Environment and Climate staff are recommending three qualified candidates for appointment as public members to the Toronto Atmospheric Fund Board. These candidates cover a range of City Council approved qualifications for the Toronto Atmospheric Fund Board with relevant knowledge and experiences.

Public release of names of recommended candidates

The names of the recommended candidates will be publicly reported once the Civic Appointments Committee forwards it recommendations to City Council.
