SUMMARY

At the June 11 meeting of the Infrastructure and Environment Committee, Committee requested that staff report directly to the June 25, 26 and 27 meeting of City Council with information on how a Toronto resident could make a complaint to the Office of the Privacy Commissioner of Canada (OPC) with respect to this matter. In response, this report outlines the role of the OPC and informs residents that they can obtain more information from the Office of the Privacy Commissioner of Canada's ("OPC") website at www.priv.gc.ca/en.

At the June 11 meeting of the Infrastructure and Environment Committee, Committee requested that staff report directly to the June 25, 26 and 27 meeting of City Council with information on how a Toronto resident could make a complaint to the Office of the Privacy Commissioner of Canada (OPC) with respect to this matter.

The Office of the Privacy Commissioner of Canada provides advice and information for individuals about protecting personal information, and is responsible for enforcement of the Personal Information Protection and Electronic Documents Act (PIPEDA) and the Privacy Act. These Acts set out rules for how personal information must be handled by federal government institutions and certain businesses.

The information made publicly available by OPC includes resources for individuals looking to get more information about privacy rights and protections in Canada. Individuals can ask the OPC about privacy concerns or can file a formal privacy complaint with the OPC if they believe "that a business or federal government institution subject to federal privacy has violated [their] privacy." The OPC's guidance regarding complaints encourages individuals "to try to resolve the concern directly with the organization before filing a complaint".
