SUMMARY

The purpose of this report is to make changes to the Upper Village and Uptown Yonge Business Improvement Area Boards of Management, in accordance with the requirements of the City of Toronto Municipal Code Chapter 19, Business Improvement Areas. Upper Village and Uptown Yonge Business Improvement Areas fall within two Community Council boundaries.

RECOMMENDATIONS

COMMENTS

From time to time, it is necessary to remove Business Improvement Area (BIA) Board of Management directors who are no longer able to serve, and add new directors to fill vacant positions, as set out in Chapter 19 of the Toronto Municipal Code. Council members are appointed by right-of-office to the boards of BIAs in their wards.

Upper Village

The appointment of one (1) director to the Upper Village BIA Board of Management will decrease the number of vacancies on the board from one (1) to zero (0). Quorum will remain at three (3).

Uptown Yonge

The appointment of one (1) director and removal of three (3) directors from the Uptown Yonge BIA Board of Management will increase the number of vacancies on the board from nine (9) to eleven (11). Quorum will remain at three (3).
