Advancing Action on the Impact to Action: Final Report on Anti-Black Racism in Toronto Police Services - Presentation Requests

Committee Recommendations

The Confronting Anti-Black Racism Advisory Committee recommends that the Economic and Community Development Committee:

1. Request the Confronting Anti-Black Racism Unit, Social Development to invite the Toronto Police Service to present to the Confronting Anti-Black Racism Advisory Committee on the status and timeline of implementation of the Ontario Human Rights Commission recommendations, including:
 - a. completed, ongoing, and pending actions by the implementation team;
 - b. performance indicators and internal accountability mechanisms; and
 - c. plans for community engagement and transparency.

Decision Advice and Other Information

The Confronting Anti-Black Racism Advisory Committee:

1. Affirmed the Ontario Human Rights Commission's From Impact to Action report and its recommendations.
2. Requested that the Confronting Anti-Black Racism Unit, Social Development integrate the Ontario Human Rights Commission's From Impact to Action report recommendations into Confronting Anti-Black Racism Advisory Committee's work plan, including:

- a. strategic alignment with relevant City strategies and equity initiatives;
- b. integration into Confronting Anti-Black Racism Advisory Committee monitoring and evaluation frameworks; and
- c. consideration of provincial and federal commitments related to anti-Black racism.

Dubi Kanengisser, Executive Director, Toronto Police Service Board gave a presentation on Toronto Police Service Board Response to Confronting Anti-Black Racism Advisory Committee Motion.
