

City of Toronto Act, 2006 Public Notice

Amendments to Chapter 546 Related to Extending Vehicle Age Limits for Vehicles-for-Hire

Toronto City Council will be considering recommendations to adopt amendments to City of Toronto Municipal Code Chapter 546

It is proposed that the amendments be adopted at the City Council meeting to be held on March 26, 27 and 28, 2025 or at a subsequent meeting. If adopted by City Council, the amendments to City of Toronto Municipal Code Chapters will:

1. Amend Chapter 546-51 to permit the maximum age limit of wheelchair accessible vehicles used as a taxicab or Private Transportation Company vehicle to be up to ten model years old.
2. Amend Chapter 546 to permit a vehicle registered with Municipal Licensing and Standards for use as a taxicab or sedan limousine as of December 31, 2024 and that is required to be replaced by March 31, 2025 to continue to be used as a taxicab or sedan limousine until August 29, 2025.
