**Subject:** Concerns Regarding Item 2025.EX23.2 – Ontario-Toronto New Deal: Advancing the Delivery of Transit Oriented Communities

Dear Mayor Chow and Members of the Executive Committee,

On behalf of the **B.O.L.D.** (Building Opportunities for Leadership & Development) Community Coalition, we are writing to express our deep concerns regarding Item 2025.EX23.2, particularly the lack of a formal commitment by the Province of Ontario—through Infrastructure Ontario—to deliver deeply affordable housing as part of the Transit Oriented Communities (TOC) strategy.

If the Ontario Line project is to be eligible for federal infrastructure funding, there must be a clear, enforceable commitment to equitable housing outcomes. Relying on market-driven development without guaranteeing affordability risks deepening the housing crisis in the very communities most impacted by these projects.

Our coalition has been actively engaging with Metrolinx since **summer 2023**. Most recently, on **Wednesday**, **April 9, 2025**, we met with **Kelly A. Hagan**, Vice President of Community Engagement at Metrolinx, to raise concerns and propose constructive solutions that could ensure the Ontario Line's success through **meaningful community engagement and tangible local benefits**.

We appreciate that following our meeting, Metrolinx reinstated regular Community Liaison Committee (CLC) meetings. However, several key issues remain unresolved, including:

- Collaboratively finalizing the CLC Terms of Reference
- Improving transparency and reporting on local hiring, procurement, and community benefit delivery
- Strengthening coordination between Metrolinx, contractors, and community partners to meet equity targets

Residents and grassroots activists have made clear that communities like **Moss Park continue to be neglected**, with little indication that these investments will result in good jobs or dignified housing. We urge the Executive Committee to **insist on binding commitments from the Province** regarding affordable housing and equitable community benefits before endorsing the Ontario-Toronto New Deal. This is a moment to ensure public investments in infrastructure also serve public good.
