GOOD MORNING MAYOR CHOW AND MEMBERS OF THE EXECUTIVE COMMITTEE

THERE REALLY SHOULD BE A RESOLUTION TO THIS MATTER IT IS NOT GOING AWAY BECAUSE YOU ALL JUST WANT TO IGNORE IT.

THERE ARE A NUMBER OF ISSUES

CORRECT PREDICTIONS OF A LIFE OR DEATH NATURE THE POLICE ALWAYS SQUANDER THEN FRANTICALLY SCRAMBLE ABOUT TO ORCHESTRATE A COVER-UP
