Dear Mayor Chow and members of the Executive Committee,

Good Morning,

I am a heavy user of the 311 system in fact my urgent calls have been marked at the highest level possible, dire emergency, priority one, code blue, a life-or-death matter.

The City has a bottom-line responsibility to find a constructive resolution to this matter, at the City level there are numerous political solutions we can Recall the Review and have Sandler explain himself, we can convene Ryerson into public hearings and voir dire my witnesses, we can punish the police by taking \$50 million out of their inflated budget which will go to a remote viewing program that can take and act on new predictions thus saving many innocent lives. This is in the City's jurisdiction, mandate, purview and catchment area to take these immediate actions.

In 2013 I called in the France set of warnings to 311 which includes incel / danforth / mcarthur with name / date / place victims' names included all of whom were alive at this time, I am reduced down to calling 311 because the desk sergeant at 40 college will violently assault walk ins with this kind of information. Sandler's investigation skills are top notch and very commendable the Review found and cross examined the 311 operator an honest witness who gave the same account as mine it is then censored from the Epstein report.

A Civilian's Review has no power to censor they must be true, honest, transparent and accountable it is an immediate and automatic recall the City must enforce, what room is the hearing going to be in? Who is going to cross Sandler?

The Review has a true copy of the France warnings, cross-examination of Ryerson and reporters, recordings of the 311 and 911 calls and further document a new set of warnings the Coronavirus pandemic, Ukrainjet752, Kobe Bryant and Gabrielle Wortman, Sandler has to explain why nothing was prevented?
