### **PROPOSAL**

On May 12, 2010, Toronto City Council enacted By-law 477-2010 to permit nine single-detached dwellings and 62 semi-detached dwellings at 720 Humberwood Boulevard. A subsequent By-law 608-2011 was enacted by Toronto City Council on May 19, 2011, to make technical amendments to the previously enacted By-law 477-2010. In accordance with the By-law, the owner entered into a Section 37 Agreement with the City of Toronto and provided a \$53,250.00 cash contribution for the construction of a surface parking lot at Indian Line Park. The surface parking lot was never constructed and is no longer needed. The City of Toronto Parks and Recreation Division has determined that the cash contribution may be used, instead, for the construction of a playground at Indian Line Park.

The Development Review Division at the City of Toronto has initiated a Zoning By-law Amendment to amend By-law 608-2011 to reallocate the Section 37 funds from the construction of a parking lot to the construction of a playground.

**Zoning By-law Amendment Appeal:** If a specified person or public body as defined under the *Planning Act* or the registered owner of any land to which by-law would apply would otherwise have an ability to appeal the decision of the Council of the City of Toronto to the Ontario Land Tribunal but the specified person or public body as defined under the *Planning Act* or the registered owner of any land to which the by-law would apply does not make oral submissions at a public meeting or make written submissions to the City of Toronto before the proposed Zoning By-law Amendment is passed, the specified person or public body as defined under the *Planning Act* or the registered owner of any land to which the by-law would apply is not entitled to appeal the by-law.

**People writing or making presentations at the public meeting:** The *City of Toronto Act, 2006*, the *Planning Act*, and the City of Toronto Municipal Code authorize the City of Toronto to collect any personal information in your communication or presentation to City Council or its committees.

The City collects this information to enable it to make informed decisions on the relevant issue(s). If you are submitting letters, faxes, e-mails, presentations, or other communications to the City, you should be aware that your name and the fact that you communicated with the City will become part of the public record and will appear on the City's website. The City will also make your communication and any personal information in it - such as your postal address, telephone number or e-mail address - available to the public, unless you expressly request the City to remove it.
