My name is annemieke wade. I am the Executive Director of the Toronto Alliance for the Performing Arts (TAPA). TAPA is a non-profit service organization that represents over 150 professional theatre, dance, and opera companies across Toronto. Our mission is to support the performing arts sector, advocate for artists, and strengthen the cultural life of our city.

I would like to express our strong support for the development application submitted by Devron Developments in York South–Weston which references a contribution of adjacent land for a new community arts centre.
