**RE: Revocation of Suspension for:**  
**Pave-1 Construction Limited**  
**IPAC Paving Limited**

Mr. John Corbo is requesting that the suspension on being awarded contracts with the City of Toronto be removed for his companies, Pave-1 Construction Limited (“Pave-1”) and IPAC Paving Limited. They are on the list of suspended and disqualified firms which can be found at: <https://www.toronto.ca/business-economy/doing-business-with-the-city/searching-bidding-on-city-contracts/suspended-disqualified-firms>

*Background*

The originating suspension was against IPAC Paving Limited (“IPAC”), Road Mill Construction Inc. and Sebastian Corbo due to the illegal activities of Sebastian Corbo that took place between June 2009 and July 2010. On February 6 and 7, 2012 City Council temporarily suspended Sebastian Corbo and his affiliated companies from bidding on any City of Toronto contracts. Mr. John Corbo’s father, Sebastian Corbo was convicted on July 12, 2012 of paying a secret commission contrary to section 426(1) of the Criminal Code of Canada. On November 27, 28 and 29 2012, City Council continued the suspension. <https://secure.toronto.ca/council/agenda-item.do?item=2012.GM18.4>

In summary, the rationale for the suspension by the City of Toronto was that since John Corbo had taken over as the sole director of the suspended entity IPAC and was also the sole director of Pave-1, those two entities must be affiliated with each other. Despite Mr. John Corbo's vigorous denials of any connection with his father and his father's illegal activities, the suspension has remained in force.

### Legal Authority

Procurement of contracts for the City of Toronto are governed by the Toronto Municipal Code Chapter 195, Purchasing [https://www.toronto.ca/legdocs/municode/1184\\_195.pdf](https://www.toronto.ca/legdocs/municode/1184_195.pdf). The original version of the Code was adopted by Council on July 6, 2000. Section 195-13.5 states:

§ 195-13.5. Illegality.

A. A supplier shall disclose any previous convictions of itself or its affiliated persons for collusion, bid-rigging, price-fixing, bribery, fraud or other similar behaviours or practices prohibited under the Criminal Code, the Competition Act or other applicable law, for which they have not received a pardon.

B. A supplier shall be deemed ineligible for an award for a minimum period of five (5) years from the date of the conviction, unless pre-approved by the Controller.

...

§ 195-13.13. Suspension of suppliers from future solicitations.

[Amended 2018-03-27 by By-law 271-2018]

A. Without limiting or restricting any other right or privilege of the City, Council may suspend a supplier's eligibility to bid for a period between one (1) and five (5) years based upon evidence that there has been a contravention of the Supplier Code of Conduct or for any other professional misconduct or omissions that adversely reflect on the commercial integrity of the supplier.

The Supplier Suspension Procedure is published at: <https://www.toronto.ca/wp-content/uploads/2018/08/9521-Supplier-Suspension-Procedure.pdf> The procedure states at 4.1 that :

“.. The maximum suspension period is five (5) years under section 195-13.13 (A) of the Purchasing Chapter. ..”

Section 5 outlines the procedure for a review of the suspension.

Where Council has authorized the suspension (§195-13.13(A) - suspensions 1 year to 5 years or otherwise determined by Council), a suspended Supplier may not apply for an additional review until the completion of half of the original suspension period, unless additional information is to be presented that was not reasonably available when the initial decision was made. ... To be eligible to be reinstated thereafter, the Supplier must submit a written case for reinstatement, including any supporting documentation that provides reasons why removing the suspension would no longer prove a risk for the City.

### Corporate Activities

Since 2012, John Corbo has been the sole director, owner and manager of IPAC and Pave-1. His father is in no way involved with either corporation either directly or indirectly.

The attached letter from **Barbara Glover**, Assistant Deputy Minister of Public Services and Procurement Canada confirms that IPAC and Pave-1 are eligible for Federal Procurement contracts.

The attached letter from **Michael Long** of The City of Mississauga, Works Operation Maintenance Division states that Pave-1 Construction and John Corbo have held contracts with the City of Mississauga and “have been a knowledgeable, efficient and competent contractor that I would be happy to work with on future contracts.”

The attached letter from **Anthony Incitto**, Road and Traffic Supervisor with the City of Richmond Hill confirms that “It has been a pleasure to work with Chris Drosinis and John Corbo (Ipac Paving Limited). Both have been very professional and I would be glad to work with them on any future contracts.”

The attached letter from **Pat Polidoro** of Fermar Paving Limited states that “... From my relationship with John [Corbo], I can say he runs his company with the utmost integrity and makes sure our business relationship is a good one. IPAC is a valued customer of ours and over the years we have seen them grow into what I can say is a well-respected and good performing company.”

The attached letter from IPAC project manager and estimator, **Chris Drosinis** confirms that John Corbo oversees all of the daily operations and hiring for the company.

The attached letter from **William Kelly**, lawyer for Pave-1 and IPAC construction lien and contract matters, confirms that John Corbo is the operating mind of both corporations.

The attached letter from **Jeff Kirshen**, lawyer for Pave-1 and IPAC tax matters, confirms that John Corbo is the controlling mind of both corporations.

Both companies employ 70 people directly and many more people indirectly through their supply network.

#### *Analysis of Suspension Removal*

IPAC was suspended 11 years ago. Pave-1 was suspended 9 years ago. The maximum suspension under the 2018 amendments is 5 years. The time period for eligibility to review the suspension under section 5 of the Suspension Review Procedures (enacted in 2018) is 2.5 years. All time periods have long since elapsed.

Both corporate entities are entitled to request a review of the suspension. It is our submission that in light of the maximum period of suspension of 5 years in section 195-13.13(A) of the Municipal Code, the suspensions should be revoked. We are however, mindful of the requirement in section 5 of the Suspension Review Procedures that mandates “providing reasons why removing the suspension would no longer prove a risk to the City.”


In our submission the reasons for removing the suspension are:

1. Sufficient time has passed since the suspension was imposed. More than 9 years have passed since the suspension was imposed on Pave-1. More than 11 years have passed since the suspension was imposed on IPAC.
2. Sebastian Corbo is not involved either directly or indirectly in the activities of either corporation.
3. There are no allegations linking John Corbo to any illegal activity or wrong doing. He is the sole controlling mind of both corporations. He operates the corporations with integrity.
4. John Corbo, Pave-1 and IPAC are well-respected contractors.
5. IPAC and Pave-1 have successfully procured contracts with at least 48 other GTA municipal entities.
6. IPAC and Pave-1 are eligible to bid on Federal Procurement contracts.
7. IPAC and Pave-1 are the only two entities on the suspension list whose terms of suspension exceed the maximum five year timeframe. It would be unreasonable to continue the suspension in light of the 2018 by-law amendments and City Council’s clear intention to limit the period of suspension.

### Conclusion

It is submitted that there is no risk to the City of Toronto in revoking the suspension on being awarded contracts with the City. John Corbo and the companies he owns are well-respected for their work and integrity. A revocation of the suspension would be a benefit to the City of Toronto and the value they receive for the work performed by John Corbo, IPAC and Pave-1.





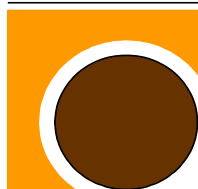
