Schedule 1: Chapters 841 and 844 Proposed Bylaw Amendments

Toronto Municipal Code Chapter 841, Waste Collection, Commercial Properties

As indicated in the staff report, the proposed amendments to Chapter 841 (Waste Collection, Commercial Properties) are:

1. To add a provision indicating that most if not all of Chapter 841 applies only to those commercial properties that are a City of Toronto customer that are not receiving producer-funded Blue Box collection service as of December 31, 2025, as further detailed in Table 1.

- 3. To modify the definition of Recyclable Materials in Chapter 841 to ensure alignment with the PROs (specifically, Circular Materials) list of acceptable materials.

Toronto Municipal Code Chapter 844, Waste Collection, Residential Properties

As indicated in the staff report, the proposed amendments to Chapter 844 (Waste Collection, Residential Properties) are:

- 1. To add a provision indicating that the City of Toronto will cease to provide collection services for Recyclable Materials as of January 1, 2026 for those residential properties that:
 - a. the Province of Ontario has determined is an eligible source that will receive such services from a Producer Representative Organization; or
 - b. the Province of Ontario has determined is not an eligible source and will not receive such services from a Producer Representative Organization but instead for a private sector entity.
- 2. To add a provision indicating that the City of Toronto will not be providing services to collect, transfer and process Recycled Material for any multi-residential building that the

- Province of Ontario has determined is not eligible for collection, transfer and processing of Recycled Materials by producer-funded operators until 2031.
- 3. To add a provision indicating that the City of Toronto will not be providing services to collect, transfer, and process Garbage, Organic Materials and Yard Waste for any multi-residential property (as defined in O. Reg 391/21: Blue Box) that is not eligible for collection, transfer and process of Recycled Materials by producer-funded operators unless the multi-residential building retains a private service provider to handle Recycled Materials and provides the City of Toronto with confirmation that such services have been retained.
- 4. To amend Article 844-3.D. in Article II Collection Services to reflect that in order for a multi-residential property (as defined in O. Reg 391/21: Blue Box to receive City garbage and organics collection as after January 1, 2026, the property owner or manager must first provide proof they have secured a private recycling collection service provider. Therefore, recycling collection provisions in this Chapter will not apply because the City will not provide recycling collection services to these locations.
