City Council is amending the Parks and Recreation's 2025-2034 Capital Budget and Plan on a one-time basis, to create a new capital sub-project known as the Jose Rizal Memorial Project in the Park Development project, with a project cost and cash flow of \$60,000 gross and \$0 debt in 2025, fully funded by Section 37 community benefits obtained from the development at 700, 702, 714 and 716 Sheppard Avenue West secured for improvements to park assets (Source Account: XR3026-3701248) for the purpose of asset improvements at the Jose Rizal Memorial in Earl Bales Park.								
City Council is also increasing the 2025 Operating Budget for Economic Development and Culture on a one-time basis by \$15,000.00 gross and \$0 net, fully funded by Section 37 community benefits obtained in the development at 700, 702, 714 and 716 Sheppard Avenue West (Source Account: XR3026-3701248), to fund maintenance of the Jose Rizal Memorial in Earl Bales Park (Cost Centre: AH0033).
