# REASON FOR CONFIDENTIAL INFORMATION

This report deals with personal matters about identifiable individuals who are being considered for appointment to the Toronto Hydro Board.

# **SUMMARY**

The Corporations Nominating Panel will conduct interviews and recommend two candidates to City Council for appointment to the Toronto Hydro Board.

# **RECOMMENDATIONS**

The City Clerk recommends that:

- 1. The Corporations Nominating Panel recommend two public members to City Council for appointment to the Toronto Hydro Board, at pleasure of Council, for a term of office ending on June 27, 2027 and until successors are appointed.
- 2. City Council direct that Confidential Attachments 1a, 1b and 2 to 4 remain confidential in their entirety as they relate to personal matters about identifiable individuals being considered for appointment to the Toronto Hydro Board.

## COMMENTS

# **Composition of the Toronto Hydro Board**

The board has a total of 11 members including:

- the Mayor or the Mayor's designate appointed by City Council
- 2 members of Council
- 8 public members who are not elected officials or employees of the City of Toronto or any of its agencies or corporations, one of whom shall be the Chair

# Public members are appointed for a two-year term

The term of office for public members of City corporations is two years, and until successors are appointed.

# Board members should collectively represent a range of expertise including:

- experience on a public utility commission or board of a major corporation or other commercial enterprise
- corporate finance
- corporate governance
- market development
- large system operation and management
- urban energy industries
- public policy issues and laws relating to Toronto Hydro and the electricity market
- environmental matters, labour relations, and occupational health and safety issues
- commercial sensitivity and acumen
- independence of judgement and personal integrity
- at least three directors with financial management expertise

# Public members should meet certain eligibility requirements

To be eligible for appointment to the board, public members must meet the eligibility requirements in the City's Public Appointments Policy.

In addition, under the *Business Corporations Act*, persons are ineligible for appointment to the board if they are:

- A person who has been found under the Substitute Decisions Act, 1992 or under the Mental Health Act to be incapable of managing property or who has been found to be incapable by a court in Canada or elsewhere.
- A person who is not an individual.
- A person who has the status of bankrupt.

## Public members receive remuneration

Members of the Toronto Hydro Board receive:

- The Chair receives an annual retainer of \$75.000
- Board members receive an annual retainer of \$12,500, plus \$1,000 per meeting up to a maximum of \$30,000

#### Public release of the names of the recommended candidates

The names and biographiesof the recommended candidates will be publicly reported once the Corporations Nominating Panel forwards its recommendation to City Council.
