

City of Toronto Act, 2006 Public Notice

Area-Specific Amendment to the Sign By-law: 2 College Street

Toronto City Council will be considering recommendations to amend Municipal Code Chapter 694, Signs, General (the "Sign By-law"), to modify the regulations that apply to the property municipally known as 2 College Street, to permit a third party electronic roof sign.

It is proposed that the amendments be adopted at the City Council meeting to be held on March 26, 2025. If adopted by City Council, the proposed amendments allow for and regulate:

- A third party electronic roof sign (the "Proposed Sign"), which is a sign type expressly prohibited.
- A sign that would have a sign face area of approximately 54 square metres and an overall height of 29.0 metres.
- A third party sign less than 100 metres of an existing third party sign and less than 30 metres of a controlled intersection.
- A third party electronic roof sign with two sign faces facing the same direction.
- A third party sign erected on a listed heritage building.

The Chief Building Official and Executive Director, Toronto Building, is recommending that the Council of the City of Toronto refuse the amendments to the Sign By-law described above.

The Planning and Housing Committee may recommend that the Council of the City of Toronto amend the Sign By-law to approve the amendments to the Sign By-law described above.
