

## **Accessible Parking Space - Northview Avenue**

### **SUMMARY**

---

This staff report is about a matter that Community Council has delegated authority from City Council to make a final decision.

Transportation Services is requesting approval for the installation of on-street accessible parking space for persons with disabilities on the south side of Northview Avenue.

### **RECOMMENDATIONS**

---

The Director, Enforcement and Street Management, Transportation Services recommends that:

1. Scarborough Community Council designate an on-street accessible parking space in effect at all times on the south side of Northview Avenue, between a point 52 metres west of Blantyre Avenue and a point 5.5 metres further west.

### **FINANCIAL IMPACT**

---

The signage costs associated with the proposed installation of the accessible parking space is approximately \$700.00. Funding is available within the Transportation Services 2025 Operating Budget.

## **DECISION HISTORY**

## **COMMENTS**

---

Transportation Services provides designated on-street accessible parking as a convenience for people with disabilities and/or those who transport them, making it easier for them to find available parking as near as possible to their place of residence or intended destinations and reducing walking distances.

Designated on-street accessible parking spaces are not for the exclusive use of any one resident. Any person with a valid Accessible Parking Permit issued by the Ministry of Transportation of Ontario (MTO) may park in any designated on-street accessible parking space. Designated on-street accessible parking spaces may be relocated for technical or operational reasons, if deemed necessary by the City.

Delays in installing on-street accessible parking spaces may create hardships for the applicants. Timely removal of a designated on-street accessible parking space when it is no longer needed, for instance when the resident moves or is no longer eligible, aids in maximizing available on-street parking for other residents/motorists.

Northview Avenue, east of Victoria Park Avenue, is a two-lane, east-west, local roadway. It operates two-way traffic on a pavement width of 8.5 metres. Parking regulations within the subject section are as follows:

### **North side**

- Parking prohibited at all times

### **South side**

- Parking by permit only, in effect from 12:01 a.m. to 7:00 a.m., daily
- Three-hour statutory parking at all other times.

To be eligible for on-street accessible parking, applicants must hold a valid Accessible Parking Permit, issued by the MTO. Staff have determined that the installation of the accessible parking space is feasible as the requirements are met and the designated space will not result in the loss of more than one on-street parking space for general use.
