

Ontario Honda Dealers Indy Toronto Race 2025 - Temporary Street Closures

SUMMARY

As the proposed street closures involve a motor vehicle race and takes place on a major arterial road, City Council approval is required.

Temporary closures to vehicular traffic will be required on Lake Shore Boulevard West, between Strachan Avenue and Ontario Drive, and on Strachan Avenue, between Fleet Street and Lake Shore Boulevard West, to facilitate the Ontario Honda Dealers Indy Toronto automobile race in 2025.

It is anticipated that the temporary closures will be from July 16, 2025 to July 21, 2025. In the event of a delay or cancellation of the race on Sunday, July 20, 2025, the final race will be held on Monday, July 21, 2025.

Section 937-3.1 of City of Toronto Municipal Code Chapter 937, Temporary Closing of Highways. Currently delegates authority to the General Manager of Transportation Services to temporarily close to vehicular and pedestrian traffic any highway or portion thereof for such periods as required for the purpose of the 2024 Honda Indy Toronto automobile race. Transportation Services is requesting that this delegation be amended to update the delegation for the purposes of the 2025 Ontario Honda Dealers Indy Toronto automobile race.

RECOMMENDATIONS

The Director, Permits and Enforcement, Transportation Services recommends that:

1. City Council grant authority to enter into a new one-year agreement with Green Savoree Toronto ULC to permit the holding of the Ontario Honda Dealers Indy Toronto event in 2025 on terms and conditions satisfactory to the General Manager of Transportation Services and in a form satisfactory to the City Solicitor.

2. City Council amend Section 937-3.1 of City of Toronto Municipal Code Chapter 937, Temporary Closing of Highways, subject to the City's execution of the agreement between the City and Green Savoree Toronto ULC described in Recommendation 1, to delegate authority to the General Manager of Transportation Services to temporarily close to vehicular and pedestrian traffic any highway or portion of a highway for such periods as required for the purposes of the 2025 Ontario Honda Dealers Indy Toronto automobile race.

3. City Council authorize and direct the appropriate City Officials to take the necessary action to give effect to City Council's decision, including the introduction in Council of any Bills that may be required.

FINANCIAL IMPACT

There is no financial impact to the City associated with the recommendations in this report. The event organizer is responsible for all costs, including a payment to the City for occupancy of the right-of-way. These fees will be approximately \$23,000 (not including HST).

COMMENTS

Section 937-3.1 of City of Toronto Municipal Code Chapter 937, Temporary Closing of Highways, provides that, despite any other by-law, the General Manager of Transportation Services of the City of Toronto may temporarily close to vehicular and pedestrian traffic any highway or portion of a highway for such periods as required for the purposes of the 2024 Honda Indy Toronto automobile race.

Accordingly, City Council authority is required to amend this delegation to reference the 2025 Ontario Honda Dealers Indy Toronto automobile race.

The Ontario Honda Dealers Indy Toronto Race ("Honda Indy") has taken place annually since 1986, when it was originally known as the Molson Indy Toronto. The racetrack route remains the same, running through the Exhibition Place grounds and extending onto Lake Shore Boulevard West between Ontario Drive and Strachan Avenue. The temporary road closures required for the event take place on Lake Shore Boulevard West between Ontario Drive and Strachan Avenue and southbound on Strachan Avenue between Fleet Street/Manitoba Drive and Lake Shore Boulevard West. These temporary road closures occur for five days beginning on the Wednesday, July 16, 2025 at 9:00 p.m. to Monday, July 21, 2025 when the roads reopen at 1:00 a.m. In the event of a delay or cancellation of the race on Sunday, July 20, 2025, the final race will be held on Monday, July 21, 2025.

Traffic Mitigation Measures

Traffic Signal Timing and Intersection Sign Modifications

Transportation Services Traffic Management Centre and the race organizer will undertake several traffic signal timing and intersection signage modifications at 16 different intersections in the surrounding area impacted by the Lake Shore Boulevard West and southbound Strachan Avenue road closures in order to improve traffic flow. A list of the locations, modifications and date and time of when these signal timing and sign changes that will be implemented are similar to previous years and will be confirmed in the Stakeholder Planning Meeting which will be held in early 2025.

Race Track Build

The race track build requires the installation of a concrete barrier wall. The installation of the concrete wall before the event and removal afterwards will take place during off-peak periods on weekday evenings/early mornings between 9:00 p.m. and 5:00 a.m. to minimize traffic impacts.

Traffic Control and Advance Warning Signs

Before January 1, 2025, the race organizer and Exhibition Place will develop the initial draft of the Honda Indy temporary road closure schedule which details the road

restrictions required to install and remove the concrete barrier wall along Lake Shore Boulevard West and within Exhibition Place. Exhibition Place is very involved in many of these measures using its established network to communicate key messaging and timing.

The race organizer will request paid-duty Police Officers at several intersections impacted by the temporary road closures to improve vehicle and pedestrian flow during the event. A list of locations where Police will be stationed will be provided in the planning meetings leading up to the event.

The race organizer's traffic control contractor places advisory and advance warning signage at the perimeter of the temporary road closures and to a larger impact area bounded by: Islington Avenue in the west, Leslie Street in the east, and Bloor Street West at the north-most extent. The sign selection and placement are done in accordance with Ontario Traffic Manual Book 7 for Temporary Conditions which provides uniform guidelines for traffic control during temporary road closures.

On the Sunday prior to the event, during the event, and until the road is reopened, Transportation Services will be providing road closure information using variable message signs (VMS) at the following locations:

1. Eastbound F.G. Gardiner Expressway near Parkside Drive
2. Eastbound Lake Shore Boulevard West near:
 - Jameson Avenue
 - British Columbia Road (portable VMS)
3. Westbound F.G. Gardiner Expressway near:
 - Cherry Street
 - York Street
 - Dufferin Street
4. Westbound Lake Shore Boulevard East near Carlaw Avenue
5. Westbound Lake Shore Boulevard West near:
 - Bay Street
 - British Columbia Drive
 - Strachan Avenue (portable VMS)

Discussions between Ontario Honda Dealers and Ontario Place, Live Nation and Infrastructure Ontario are on-going to determine vehicle access in and around Ontario Place during the Honda Indy event.

The Martin Goodman Trail will remain open to cyclists and pedestrians during the Honda Indy event.

During the event, the F.G. Gardiner Expressway ("Gardiner") on and off-ramps at Jameson Avenue/Dunn Avenue and Jameson Avenue/British Columbia Drive will remain open to vehicular traffic at all times. The traffic barrier arms which typically

restrict access to the Gardiner on weekdays during the a.m. and p.m. peak periods will remain open on the Thursday and Friday when Lake Shore Boulevard West is closed for the event.

Media

Transportation Services and the City's Strategic Public and Employee Communications staff work together to provide timely and detailed information on the planned lane reductions required during the concrete barrier wall setup and takedown as well as the Lake Shore Boulevard West and Strachan Avenue (southbound) road closures. This information is released by Strategic Public and Employee Communications to all media outlets which include radio, television, social media and print (including all ethnic community papers) approximately two to three days in advance of the lane restrictions and up to one week ahead of the temporary road closures.

Notice of the Honda Indy road restrictions and temporary closures are communicated out by both Transportation Services' affiliated X account and Strategic Public and Employee Communications' X account. The lane restrictions required during the setup and takedown of the concrete barrier wall are tweeted out approximately two to three days prior to the work taking place. Notice of the Honda Indy event temporary road closures are tweeted out approximately two weeks prior to the event. All road restriction and road closure information is also provided on the City's website.

The Toronto Transit Commission ("TTC") manages its own media protocol for all streetcar and bus diversionary routing as well as the Honda Indy shuttle bus routing it provides to and from the event.

Community and Stakeholder Meetings

Exhibition Place together with the race organizer annually hosts pre and post-event community liaison meetings. Notice of these meetings are provided to the local Councillors' offices in order to notify the neighbouring communities and the Parkdale and Liberty Village Business Improvement Areas. Resident Associations are notified directly. Notice of the meetings are also posted on the Exhibition Place website and announced at Exhibition Place meetings.

An annual Stakeholder Planning Meeting will be held on or before April 1st with TTC, GO Transit, Metrolinx, Toronto Police, Toronto Fire, EMS, Maple Leaf Sports and Entertainment (BMO Field), Hotel X, Live Nation (Budweiser Stage), Ontario Place, Exhibition Place, Transportation Services and Honda Indy operations, contractors and vendors. Stakeholder meetings are held prior to the event to discuss the move-in and construction schedule as it relates to impacted roads and any possible temporary road restrictions/closures. These meetings were found to be beneficial from a coordination and planning perspective and will be scheduled to continue prior to the 2025 event.

Traffic Mitigation Plan Improvements

Year to year, Transportation Services and the race organizer look to make continual improvements to mitigate traffic impacts through signal timing modifications, advance warning signs, paid-duty Police positioning, improving communications through Strategic Public and Employee Communications group, and updating the traffic plan based on construction.

A site plan is included in Attachment 1.

Transportation Services is satisfied that the event organizer has explored all options to minimize the impact of the temporary closure on all road users. City staff will continue to liaise internally and with area stakeholders as required to ensure all traffic management measures for this event are carried out in a comprehensive manner. Upon completion of the event, Transportation Services staff, in consultation with the local Councillors, event organizers and other stakeholders, will evaluate the traffic management plan. Lessons learned will be implemented in the design of traffic management plans for future street event closures.

The Ward Councillor has been advised of the recommendations of this staff report.
