# NOTICE OF PUBLIC MEETING

To be held by Toronto and East York Community Council (Under the Planning Act)

Request to Amend the Official Plan and Zoning By-law Application Numbers 24 168035 STE 09 OZ and 24 169956 STE 09 OZ

Location of Application: 158 Sterling Road (Blocks 5B, 5C, and 5D) & 190 Sterling Road

(Block 3B)

Applicant: Marlin Spring

#### **PROPOSAL**

The applications to amend the Official Plan and Zoning By-law propose a 28-storey building on 190 Sterling Road - Block 3B with a total Gross Floor Area (GFA) of approximately 22,422 square metres, of which 1,317 square metres is proposed to be non-residential GFA. The application on Block 3B includes a new 62-space childcare centre that is approximately 928 square metres in size, which is proposed to be conveyed to the City as an in-kind community benefits contribution. The applications also propose a 31-storey building on 158 Sterling Road - Block 5B with a total GFA of approximately 25,109 square metres, of which 862 square metres is proposed to be non-residential GFA. A one-storey building is proposed on 158 Sterling Road - Block 5C with a total non-residential GFA of approximately 978 square metres. The proposal on Block 5B also includes approximately 720 square metres of privately owned, publicly accessible space (POPS), which takes the form of a central courtyard.



**If you wish to be notified** of the decision of the City of Toronto on the proposed Official Plan Amendment and/or passing or refusal of the proposed Zoning By-law Amendment, you must make a written request to the City Clerk attention: Cathrine Regan, City Clerks Planning Registrar, at the address, fax number or e-mail set out above.

Official Plan and Zoning By-law Amendment Appeal: If a specified person or public body as defined under the Planning Act or the registered owner of any land to which the plan or by-law would apply would otherwise have an ability to appeal the decision of the Council of the City of Toronto to the Ontario Land Tribunal, but the specified person or public body as defined under the Planning Act or the registered owner of any land to which the plan or by-law would apply does not make oral submissions at a public meeting or make written submissions to the City of Toronto before the proposed Official Plan Amendment is adopted or Zoning By-law Amendment is passed, the specified person or public body as defined under the Planning Act or the registered owner of

any land to which the plan would apply is not entitled to appeal the decision to adopt the proposed Official Plan Amendment or the by-law.

**People writing or making presentations at the public meeting:** The *City of Toronto Act, 2006*, the *Planning Act*, and the City of Toronto Municipal Code authorize the City of Toronto to collect any personal information in your communication or presentation to City Council or its committees.

The City collects this information to enable it to make informed decisions on the relevant issue(s). If you are submitting letters, faxes, e-mails, presentations, or other communications to the City, you should be aware that your name and the fact that you communicated with the City will become part of the public record and will appear on the City's website. The City will also make your communication and any personal information in it - such as your postal address, telephone number or e-mail address - available to the public, unless you expressly request the City to remove it.

Many Committee, Board and Advisory Body meetings are broadcast live over the internet for the public to view. If you speak at the meeting you will appear in the video broadcast.
