

## **Appointment of Public Members to the Moss Park Arena Board**

### **REASON FOR CONFIDENTIAL INFORMATION**

---

This report deals with personal matters about identifiable individuals who are being considered for appointment to the Moss Park Arena Board.

### **SUMMARY**

---

City Council has authorized the City Clerk to shortlist, interview and recommend candidates to Community Councils for appointment to the Moss Park Arena Board. This report recommends one candidate for appointment to the board.

### **RECOMMENDATIONS**

---

The City Clerk recommends that:

1. Toronto and East York Community Council appoint the following candidate to the Moss Park Arena Board, at pleasure of Council, for a term of office ending on April 4, 2029, and until a successor is appointed:

- Anwar Hakim Mohamed

2. Toronto and East York Community Council appoint April Hodgins as the member nominated by the Moss Park House League, for a term of office ending December 5, 2028, and until a successor is appointed.

3. Toronto and East York Community Council direct that Confidential Attachment 1 remain confidential in its entirety as it relates to personal matters about identifiable individuals being considered for appointment to the Moss Park Arena.

## COMMENTS

### Composition of the Moss Park Arena Board

The board is composed of:

- The Councillor for Ward 13
- 9 public members, 1 of whom may be nominated by the Central Toronto Skating Club and 1 of whom may be nominated by the Moss Park House League
- 1 non-voting staff member from the Parks, Forestry and Recreation Division

### **There is currently one position under consideration and one title change for an existing public member**

One position under consideration is the result of one public member's term that came to an end on February 25, 2025.

One public member currently serving on the board has been nominated as a stakeholder representative by the Moss Park House League.

### Term of office

The term of office for public appointees to the Moss Park Arena Board is four years.

The new member appointed will serve a term of office ending April 4, 2029, and until successor is appointed.

The stakeholder representative will continue to serve their current term ending on December 5, 2028, and until a successor is appointed.

### **The City Clerk recruits and recommends candidates for Arena Boards to Community Council**

City Council has authorized the City Clerk to screen, interview and recommend candidates for the Moss Park Arena Board to the Toronto and East York Community Council.

City Clerk's staff conducted outreach to attract diverse, qualified individuals with relevant skills and qualifications, including non-profit experience, finance, and fundraising. To attract qualified candidates, City Clerk's staff promoted the opportunity to various professional and community organizations. Consideration was also given to ensure diverse representation on the Moss Park Arena Board.

Staff from the City Clerk's Office and Parks, Forestry and Recreation shortlisted eight candidates based on the City Council approved qualifications and eligibility criteria. Parks, Forestry and Recreation staff were asked to participate on the panel given their familiarity with the Moss Park Arena and community recreation programs and services in Toronto. The panel consisted of:

- Operation Support Officer, Community Recreation, Parks, Forestry & Recreation
- Acting People Services Consultant, Public Appointments, City Clerk's Office

The panel selected the recommended candidates by weighing candidate applications and interview performances, and the different perspectives and representation that each would bring to the board.

### **Diversity Outreach**

The City Clerk's Office prioritized outreach to equity-deserving groups in order to foster diverse representation on the board, aligning with the values outlined in the City's Public Appointments Policy. The opportunity was promoted using social media, volunteer job boards, and to various professional and community organizations within the Moss Park Arena catchment area. These organizations provide services to a large diverse population in Ward 13.

In preparation for the recruitment process, staff from the City Clerk's Office communicated with the Moss Park Arena Board Ward Councillor and their staff to consult on board member requirements. Meetings with the Arena Manager and Board Chair were also held to discuss any current skills gaps on the Moss Park Arena Board.

These outreach and recruitment initiatives resulted in an increase of applications from members of equity-deserving groups.

### **Staff is recommending one highly qualified candidate for appointment**

Parks, Forestry and Recreation and City Clerk's staff are recommending one highly qualified candidate for appointment to Moss Park Arena Board (see Attachment 1). This candidate cover the range of City Council approved qualifications for Moss Park Arena Board with the relevant knowledge and experience.

### **The Moss Park House League has nominated one qualified candidate**

The stakeholder representative being nominated by the Moss Park House League has already been appointed to the board. The nomination will result in a change of title from public member to stakeholder representative.
