Re: Parking Amendments – Boulton Avenue (Dundas Junior Public School)

Dear Councillor Moise and Toronto and East York Community Council,

Parking amendments are recommended on Boulton Avenue with respect to the City-wide review of impacts from changes to school operating times directed through IE12.15. Since June 2020 when these changes were implemented - Dundas Junior Public School staff, TDSB Trustee Ehrhardt, and affected parents have expressed safety concerns regarding the signage on Boulton Avenue, south of Dundas Street East. Transportation staff recommends the following amendments to alleviate traffic and ensure safe pick up and drop off for students, parents, school bus drivers, and residents alike.

Recommendations:

1. Toronto and East York Community Council amend the existing school bus loading zone, in effect from 8:30 a.m. to 4:00 p.m., Monday to Friday, except public holidays, from September 1 of one year to June 30 of the next following year, inclusive, on the west side of Boulton Avenue between a point 30.5 metres south of Dundas Street East and a point 28 metres further south, to be in effect from 8:00 a.m. to 4:00 p.m., Monday to Friday, except public holidays, from September 1 of one year to June 30 of the next following year, inclusive.
2. Toronto and East York Community Council amend the existing maximum 10-minute parking regulation, in effect from 8:30 a.m. to 9:00 a.m. and 2:30 p.m. to 3:00 p.m., Monday to Friday, except public holidays from September 1 of one year to June 30 of the next following year, inclusive, on the west side of Boulton Avenue between a point 58.5 metres south of Dundas Street East and a point 25.5 metres further south, to be in effect from 8:15 a.m. to 8:45 a.m. and 2:30 p.m. to 3:00 p.m., Monday to Friday, except public holidays from September 1 of one year to June 30 of the next following year, inclusive.

3. Toronto and East York Community Council amend the existing parking prohibition, in effect from 9:00 a.m. to 2:30 p.m., Monday to Friday, except public holidays from September 1 of one year to June 30 of the next following year, inclusive, on the west side of Boulton Avenue between a point 58.5 metres south of Dundas Street East and a point 25.5 metres further south, to be in effect from 8:45 a.m. to 2:30 p.m., Monday to Friday, except public holidays from September 1 of one year to June 30 of the next following year, inclusive.
4. Toronto and East York Community Council rescind the existing permit parking regulation in effect from 12:01 a.m. to 8:30 a.m. all times except no parking anytime from a point 30.1 metres north of Clark Street to a point 6.8 metres further north on the even (west) side of Boulton Avenue, from Clark Street to Dundas Street East.
5. Toronto and East York Community Council authorize permit parking to be in effect from 12:01 a.m. to 8:00a.m. daily on the even (west) side of Boulton Avenue, from Clark Street to Dundas Street East.
