

## APPENDIX C

### Amendments to Toronto Municipal Code Chapters

The Toronto Municipal Code is comprised of three parts: Part I – Administrative By-laws; Part II – General By-laws; and Part III – Traffic and Parking By-laws. As part of this review, staff examined 71 Municipal Code Chapters within Parts II and III that contain provisions prescribing fines for contraventions. Of these 71 chapters, the maximum allowable fines for 30 are currently set at the COTA maximum of \$100,000 and include provisions for charging officers and directors of a corporation who knowingly concur in the contravention of the chapter. An additional 22 chapters are not recommended for amendment or are excluded from this review for various reasons, including where fines are prescribed by legislation other than COTA, are under active divisional review, have been repealed, or are otherwise considered to have an adequate fine structure.
