

## **Appointment of Public Members to the Toronto Local Appeal Body**

### **REASON FOR CONFIDENTIAL INFORMATION**

---

This report deals with personal matters about identifiable individuals who are being considered for appointment to the Toronto Local Appeal Body.

### **SUMMARY**

---

The Nominating Panel - Toronto Local Appeal Body will conduct interviews and recommend three candidates to City Council for appointment to the Toronto Local Appeal Body.

### **RECOMMENDATIONS**

---

The City Clerk recommends that:

1. The Nominating Panel - Toronto Local Appeal Body recommend three public members for appointment to the Toronto Local Appeal Body for a term of office beginning on July 17, 2026, and ending on July 17, 2030, and until successors are appointed.
2. The Nominating Panel - Toronto Local Appeal Body direct that Confidential Attachments 1a, 1b, and 2-4 remain confidential in their entirety as they relate to personal matters about identifiable individuals being considered for appointment to the Toronto Local Appeal Body.

## **Composition of the Toronto Local Appeal Body**

The Toronto Local Appeal Body consists of 10 public members, including a Chair and Vice Chair.

### **There are currently three positions under consideration**

At its meeting held on May 21 and 22, 2025, City Council decreased the panel member composition of the Toronto Local Appeal Body from 14 to 10 part-time members including a Chair and Vice-Chair, and that the decrease be achieved through the elimination of Toronto Local Appeal Body member positions upon the completion of current terms of appointment, with the exception of any public appointments required for the Chair position, until such point as the Toronto Local Appeal Body membership is comprised of 10 members inclusive of a Chair and Vice-Chair.

Currently the Toronto Local Appeal Body has 11 members. Following this recruitment the tribunal will achieve the decrease in composition to 10 members. There are three positions under consideration due to the end of terms of Gerald Swinkin and Carissa Wong on March 9, 2026, and Ron Kanter and Trevor Kezwer whose terms will end on July 16, 2026, and until successors are appointed.

### **Term of office**

The term of office for public members is four years. The members appointed through this process will have a term of office ending July 17, 2030, and until successors are appointed.

Under the *Statutory Powers Procedure Act*, members are also required to continue beyond their term of office or resignation date to complete hearing any matters of which they are seized.

### **Public members should meet certain qualifications**

Members should collectively bring the following skills and expertise to the tribunal:

- Experience in adjudication and mediation;
- Knowledge and experience with land use planning and planning law;
- Knowledge of or background in urban forestry and environmental planning;
- Excellent listening skills and ability to analyze complex evidence;
- Sound judgement, tact, fairness and decorum;
- Ability to write clearly and concisely;
- Demonstrated high ethical standards and integrity;
- Ability to work under pressure to ensure timely hearing decisions; and
- Respect for access to justice, diversity and accommodation.

### **Members must satisfy certain eligibility requirements**

In addition to the general eligibility requirements set out in the Public Appointments Policy, members of the Toronto Local Appeal body must meet these criteria:

- Cannot be a member of Toronto's Committee of Adjustment, a land division committee, or planning advisory committee member;
- Former Members of Council who served in the immediately preceding term of Council are ineligible for appointment; and
- Members cannot act as agents for applicants before the Committee of Adjustment, Toronto Local Appeal Body and other City administrative tribunals and would be required to resign from the Toronto Local Appeal Body before doing so.

### **Short-listed candidates will write an assignment and be interviewed**

Candidates were asked to complete an assignment related to the roles and responsibilities for Toronto Local Appeal Body members. The Nominating Panel - Toronto Local Appeal Body will be provided with the test results during the interviews.

### **Public Appointments staff have consulted with Court Services**

In preparation for this process, Public Appointments staff consulted with Court Services. In addition to the council approved qualifications, it was suggested that candidates who can conduct hearings via Web or Teleconferencing platforms and who are comfortable utilizing Microsoft 365 software, databases, and information management systems would be an asset to the tribunal.

### **Members receive remuneration**

Public members including the Chair and Vice-Chair, receive a full-day per diem of \$600 and half-day (3.5 hours or less) per diem of \$400 for hearings, business meetings or training sessions. Members also receive remuneration for decisions including: \$50 for withdrawals, \$200 for motions, interim, summary and order decisions, \$400 for review requests and \$400 for final decisions.

In addition, members receive an annual stipend pro-rated from the time of appointment. The Chair receives an annual stipend of \$60,000; the Vice Chair receives an annual stipend of \$15,000 and public members receive an annual stipend of \$1,500.

### **Public release of the names of the recommended candidates**

The names and biographies of the recommended candidates will be publicly reported once the Nominating Panel - Toronto Local Appeal Body forwards its recommendations to City Council.
