At its meeting of December 16, 2011, the Board approved the Public Complaints Policy in response to City Council's directive dated February 7, 2011, requiring all City agencies, boards, commissions and departments to adopt a public complaint process which would be the initial review and assessment of public complaints prior to appeal by the public complainant to the Office of the Ombudsman.
