

Accessible Parking Spaces - January 2026

SUMMARY

This staff report is about a matter that Community Council has delegated authority from City Council to make a final decision.

Transportation Services is requesting approval for the installation of on-street accessible parking spaces for persons with disabilities.

RECOMMENDATIONS

The Director, Enforcement and Street Management, Transportation Services recommends that:

1. Etobicoke York Community Council authorize the installation of on-street accessible parking spaces at the locations identified in Attachment 1 to this report.
2. Etobicoke York Community Council amend parking regulations required in Chapter 950, as generally described in Attachment 2 - Technical Amendments.

FINANCIAL IMPACT

The signage costs associated with the proposed installation of accessible parking spaces is approximately \$2,000. Funding is available within the Transportation Services interim 2026 Operating Budget.

DECISION HISTORY

This report addresses a new initiative.

COMMENTS

Transportation Services provides designated on-street accessible parking as a convenience for people with disabilities and/or those who transport them, making it easier for them to find available parking as near as possible to their places of residence or intended destinations and reducing walking distance.

Designated on-street accessible parking spaces are not for the exclusive use of any one resident. Any person with a valid Accessible Parking Permit issued by the Ministry of Transportation of Ontario (MTO) may park in any designated on-street accessible parking space. Designated on-street accessible parking spaces may be relocated for technical or operational reasons, if deemed necessary by the City.

Delays in installing on-street accessible parking spaces may create hardships for the applicants. Timely removal of a designated on-street accessible parking space when it is no longer needed, for instance when the resident moves or is no longer eligible, aids in maximizing available on-street parking for other residents/motorists.

To be eligible for on-street accessible parking, applicants must hold a valid Accessible Parking Permit, issued by the MTO. Staff have determined that the installation of on-street accessible parking spaces, as listed in Attachment 1, is feasible as the requirements are met and each designated space will not result in the loss of more than one on-street parking space for general use.

Housekeeping Issues

Transportation Services discovered a technical error in the Chapter 950 Schedule XIII - No Parking entry where the street name referenced "Sandcliffe Road" and not "Sandcliff Road". Recommendation 2 will rectify the error and will require no changes to the posted signage.

The Ward Councillors have been advised of the recommendation in this report.

3	Seventeenth Street, west side, between a point 22 metres north of Lake Shore Boulevard West and a point 5.5 metres further north.
5	Sandcliff Road, north side, between a point 92.2 metres west of Stoneleigh Road and a point 5.5 metres further north, from December 1 of one year to March 31 of the next following year, inclusive, and from the 16th day to the last day of each month from April 1 to November 30th, inclusive.
5	Sandcliff Road, north side, between a point 97.7 metres west of Stoneleigh Road and a point 5.5 metres further west, from December 1 of one year to March 31 of the next following year, inclusive, and from the 16th day to the last day of each month from April 1 to November 30th, inclusive.
