Notice was given and the application considered on Thursday, April 23, 2026, as required by the Planning Act.

THE CONSENT REQUESTED:

To obtain consent to sever the lot into two undersized residential lots, to construct a pair of semi-detached fourplexes with garden suites in the rear yards and to create an easement/right-of-way for the purpose of pedestrian access.

Conveyed - Parts 2, 3 and 4

Address to be assigned

Parts 2, 3 and 4 will have a combined lot frontage of 6.53 m and a combined lot area of 228.8 m². The existing dwelling will be demolished and the property will be developed as the site of a new semi-detached fourplex with a garden suite in the rear yard and will require variances to the Zoning By-law, as outlined in Application A0048/26EYK.

Easement - Part 3

Part 3 has an area of 67.45 m² and will be subject to an easement/right-of-way in favour of Part 1, for the purpose of pedestrian access.

Retained - Part 1

Address to be assigned

The lot frontage will be 5.66 m and lot area will be 198.27 m². The existing dwelling will be demolished and the property will be developed as the site of a new semi-detached fourplex with a garden suite in the rear yard and will require variances to the Zoning By-law, as outlined in Application A0047/26EYK.

File Numbers B0008/26EYK, A0047/26EYK and A0048/26EYK will be considered jointly.

The Committee of Adjustment considered the written submissions relating to the application made to the Committee before its decision and oral submissions relating to the application made at the hearing. In so doing, **IT WAS THE DECISION OF THE COMMITTEE OF ADJUSTMENT THAT:**

The Consent Application is Refused

In the opinion of the Committee, the application does not satisfy the requirements of Section 51(24) of the Planning Act and is **NOT** approved for the following reason(s):

- The proposed land division is premature.
- The proposed land division does not conform to the policies of the official plan.
- The suitability of the land for the purposes for which it is to be subdivided has not been demonstrated.
- The suitability of the dimensions and shapes of the proposed lots has not been demonstrated.
