NOTICE OF PUBLIC MEETING

PROPOSAL

The City of Toronto (City Planning and Development Review Division) has undertaken a comprehensive study for the area generally bounded by Highway 401 to the north and Ellesmere Road to the south, with irregular boundaries extending just west of Brimley Road and eastward along Bellamy Road North, East Highland Creek, and the TTC McCowan Yard spur line. The study has resulted in a proposed amendment to the Official Plan (OPA 871) to replace the 2005 Scarborough Centre Secondary Plan.

OPA 871 updates the policy framework to guide future growth in Scarborough Centre. It introduces new policies to manage growth within the area, including policies related to land use, public realm, parkland, mobility, built form, servicing and transportation infrastructure, and community services and facilities. To strengthen the Plan Area's relationship with nearby *Employment Areas*, OPA 871 proposes changes to the Secondary Plan boundary by removing the *Centres* overlay from 1680 Brimley Road and part of 333 Progress Avenue, taking these lands out of the Secondary Plan. The portion of 333 Progress Avenue removed would also be redesignated from *Mixed Use Areas* to *Core Employment Areas*. OPA 871 also updates the land use framework to guide appropriate intensification and support the creation of a complete community. It redesignates lands for seven new parks from *Mixed Use Areas* to *Parks*, and lands for two new natural areas from *Mixed Use Areas* to *Natural Areas*.

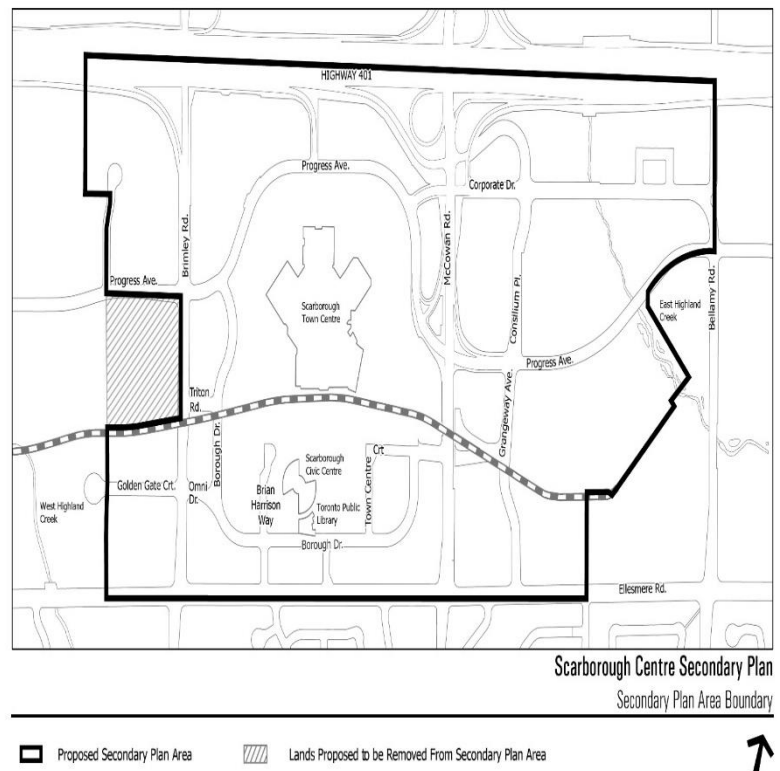

FURTHER INFORMATION

If you wish to be notified of the decision of the City of Toronto on the proposed Official Plan Amendment, you must make a written request to the City Clerk attention: Nancy Martins, Administrator, at the address, fax number or e-mail set out above.

Official Plan Amendment Appeal: If a specified person or public body as defined under the Planning Act or the registered owner of any land to which the plan would apply would otherwise have an ability to appeal the decision of the Council of the City of Toronto to the Ontario Land Tribunal but the specified person or public body as defined under the Planning Act or the registered owner of any land to which the plan would apply does not make oral submissions at a public meeting or make written submissions to the City of Toronto before the proposed Official Plan Amendment is adopted, the specified person or public body as defined under the Planning Act or the registered owner of any land to which the plan would apply is not entitled to appeal the decision to adopt the proposed Official Plan Amendment.



People writing or making presentations at the public meeting: The *City of Toronto Act, 2006*, the *Planning Act*, and the City of Toronto Municipal Code authorize the City of Toronto to collect any personal information in your communication or presentation to City Council or its committees.

The City collects this information to enable it to make informed decisions on the relevant issue(s). If you are submitting letters, faxes, e-mails, presentations, or other communications to the City, you should be aware that your name and the fact that you communicated with the City will become part of the public record and will appear on the City's website. The City will also make your communication and any personal information in it - such as your postal address, telephone number or e-mail address - available to the public, unless you expressly request the City to remove it.
