AMENDMENT NO. 966 TO THE OFFICIAL PLAN

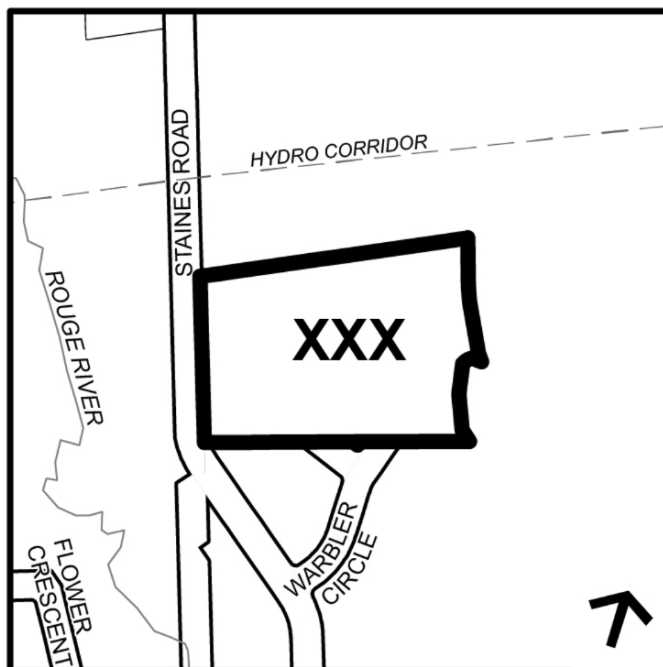
LANDS MUNICIPALLY KNOWN IN THE YEAR 2025 AS PART OF 311 Staines Road

The Official Plan of the City of Toronto is amended as follows:

1. Map 23, Land Use Plan, is amended by re-designating a portion of the lands known municipally as part of 311 Staines Road from *Natural Areas* to *Neighbourhoods*, shown on the attached Appendix 1.
2. Chapter 6, Section 3, Morningside Heights Community Secondary Plan, Map 3-1: Land Use Plan, is amended to show the lands known municipally in 2025 as part of 311 Staines Road as Site and Area Specific Policy 3.5, and by removing Parks and Open Space, Area 'D' (Park), as shown on the attached Appendix 2.
3. Chapter 6, Section 3, Morningside Heights Community Secondary Plan, is amended by adding the following subsection to Section 3, Site and Area Specific Policies:

"3.5. 251 Staines Road (Formerly Addressed: 311 Staines Road)

- (a) For the lands shown as 5 on Map 3-1, notwithstanding Policy 1.2.1, a community centre, including associated entertainment and performing arts uses, is permitted."
