Re: Traffic Calming – Margueretta Street, between Dundas Street West and College Street (Ward 9, Davenport)

Transportation Services has been requested by the Ward 9 Councillor to provide recommended wording for recommendations they plan to present to the July 8 and 9, 2026, Toronto and East York Community Council. Staff request that this memorandum accompany the Councillor's letter.

This memorandum is about a matter that Community Council has delegated authority from City Council to make a final decision.

Draft Recommendations

1. *Toronto and East York Community Council authorize the installation of traffic calming (three speed humps) on Margueretta Street, between Dundas Street West and College Street, generally as shown on the attached Drawing No. TC-720, dated May 2026 from the Director, Enforcement and Street Management, Transportation Services.*

At the request of the Ward Councillor, staff evaluated the feasibility of implementing traffic calming (speed humps) on Margueretta Street, between Dundas Street West and College Street. The surrounding area experiences a high volume of foot traffic associated with nearby pedestrian generators, which include Shirley Street Junior Public School, St. Helen Catholic School, Toronto Shirley St YMCA Child Care Centre, St. Helen's Parish, the Vine Presbyterian Church, Olivet Baptist Church, Dundas-St. Clarens Parkette, businesses on Dundas Street West and College Street, and residential neighborhoods. It is reported that motorists are speeding on the subject street, and it is used as a cut through between Dundas Street West and College Street.

Speed humps are already installed on the section of Margueretta Street to the north, between College Street and Bloor Street West (west intersection) and between Bloor Street West (east intersection) and Wallace Avenue. Installing speed humps on the subject segment would provide traffic calming on the entirety of Margueretta Street.

As the Councillor has indicated they would like to forgo the study process, motorist speed and volume data were not collected, and staff have not evaluated the installation of traffic calming measures (speed humps) on the roadway. Staff conducted a site visit in May 2026 to map the proposed speed hump locations.

Financial Impact

Staff have not been able to develop engineering estimates for this work but based on previous experience and similar work in the past, staff expect the costs associated with approving the draft recommendations above will be approximately \$12,000.00. As this work was not anticipated, it has not been specifically included in any approved budgets. Completion of the work would be subject to availability and competing priorities within future Transportation Services Capital Budgets, unless a specific funding source is identified by the Councillor and approved by Toronto and East York Community Council.
