Minuted Items

- 1. What is the monitoring schedule? It was noted that the last monitoring report is dated May 2003 and the SSRA notes that sampling at Sites A & B would be carried out semi-annually. John Minor said he would look into the schedule.
- 2. A member of the committee requested information about groundwater movement and its relevance to this SSRA.
- 3. Presentation to the Community, it was suggested that an overview be presented to the community in advance of the presenting the monitoring results. Committee members thought they should start to prepare for a public meeting.
- 4. There was discussion about the meaning of the term 'significant' when used to describe certain toxic parameters. It was noted that significant indicated numbers above levels set by the government. The primary interest is to make sure the public is safe. It was explained that capping ensures that the public is separated from contamination, and the purpose of monitoring is to show that things are stable and not getting worse.
- 5. There was discussion about the zoning of Sites A & B.
 - Review of the May 14, 2002 SSRA Report includes the following text. The "proposed land use for both areas is landscaped pedestrian traffic throughways (walkways and bicycle paths") Page 14, SSRA. "....the MOEE Table B criteria for commercial/industrial land use non-potable groundwater, coarse-textured soils were determined to be appropriate for the site", page 6, SSRA. Neither of these SSRA references addresses zoning, as in Official Plan zoning. It appears land use and remediation criteria are what is considered in this SSRA.
- 6. Sites A& B were remedied to SSRA Level Two standards which includes a list of activities outlined in the executive summary of the May 14, 2002 SSRA Report, prepared by Shaheen & Peaker Ltd. SSRA Level One indicated no adverse impacts from the site(s). SSRA Level Two indicates management tools must be used to ensure human and environmental protection. Contaminate modeling is based on worse case scenario.
- 7. Committee members requested maps, briefing notes and a brief presentation to help bring them "up to speed". Paul Young provided a brief background presentation at the meeting. The executive summary and the Drawings section of the SSRA report contain requested information. It was suggested that this information also be made available to the community, therefore a newsletter was suggested. It was also advised that we need to effectively communicate risk safety to the public. We need to be able to answer the question "will I get hurt?".
- 8. It was noted that new SSRA guidelines will come into effect in Oct. 2004. However the work done for this SSRA will be grandfathered in, under the guidelines it was prepared under.
