"SuperCorp: How Vanguard Companies Create Innovation, Profits, Growth, and Social Good," a manifesto for leadership of sustainable enterprises, was named one of the ten best business books of 2009 by Amazon.com.

Professor Kanter holds the Ernest L. Arbuckle Professorship at Harvard Business School, where she specializes in strategy, innovation, and leadership for change. She is also Chair and Director of the Harvard University Advanced Leadership Initiative, an innovation that helps successful leaders at the top of their professions apply their skills to national and global challenges in their next life stage. A collaboration across all of Harvard, the Advanced Leadership Initiative aims to build a new leadership force for the world.

Under MAP-21, Federal Transit Administration grantees must develop a Transit Asset Management Plan, including an asset inventory with condition assessments and an investment prioritization process. Performance based planning and programming (PBPP) involves the application of performance management within the planning and programming processes of agencies to achieve desired performance outcomes for the multimodal transportation system. Development of long-range transportation plans, federally required Asset Management Plans, and regional and state-level programming documents are all elements of PBPP. This performance-based approach to planning and programming attempts to ensure that transportation decisions are made- both long-term and short-term based on their ability to meet established goals.
