Re: **Ward 11 Canada Day Celebration**

---

Every year the annual Canada Day Celebration in Ward 11 is held at Weston Lions Park with funds raised through my office and funds obtained by the Government of Canada through the Department of Canadian Heritage which, through their Celebrate Canada program, provides financial support for activities celebrating Canada's heritage including Canada Day. The application for the Ward 11 Canada Day Celebration has historically been submitted by the Mount Dennis BIA with the deadline to submit funding applications for this program being January 16, 2012.

The Celebrate Canada grant application form has historically been submitted under the Mount Dennis BIA's name, with the actual event organized entirely through my office. For this reason, the event is advertised as a Council Member-Organized Community Event.

A grant in the amount of \$7000 was awarded by the Government of Canada for the Ward 11 Canada Day Celebration; because the application was submitted under the Mount Dennis BIA's name, the cheque issued was made payable to the Mount Dennis BIA. To date, my office has raised a total of \$4,850 (including in-kind donations) for the Canada Day Celebration, with two more contributions expected which would bring the total contributions raised to \$5,250.

As there is a \$10,000 limit for financial contributions for Council Member-Organized Community Events, a cheque from the Mount Dennis BIA forwarding the full grant received from the Government of Canada cannot be accepted. For this reason, the Mount Dennis BIA has issued a cheque to the City of Toronto in the amount of \$4,750 and will be issuing another cheque to the Government of Canada in the amount of \$2,250 to return the balance of the grant that cannot be used. If desired, a copy of this cheque, once issued, can be provided to you for your records.

I trust that the above arrangement is acceptable as any problems accepting this grant would result in the cancellation of this year's celebration for which contracts have already been entered into. Going forward, I will continue holding this event as a Council Member-Organized Community Event and will submit the Celebrate Canada Funding Application accordingly so that any grant received is made payable directly to the City of Toronto.

**Re:** **Ward 11 Canada Day Celebration**

Further to my memo dated June 22, 2012 wherein I explained that the Mount Dennis BIA was issuing a cheque to the City of Toronto in the amount of \$4,750 to forward the Celebrate Canada grant received from the Department of Canadian Heritage to hold the annual Ward 11 Canada Day Celebration. As you may recall, the full amount of the grant received was \$7,000; however, we could not accept the full amount as it would have put the event over the \$10,000 limit for Council Member-Organized Community Events.

One of our event sponsors who had committed to providing a \$200 contribution towards the Ward 11 Canada Day Celebration has since advised that he is no longer able to financially contribute to this event; this means that another \$200 can be accepted from the Celebrate Canada Grant. For this reason a cheque has been issued to the City of Toronto by the Mount Dennis BIA in the amount of \$200 to forward the additional money that can now be accepted from the grant.

To summarize:

<b>Amount of grant to be returned to Department of Canadian Heritage by Mount Dennis BIA</b>	<b>\$2,050</b>

As outlined above, the Mount Dennis BIA will be issuing a cheque to the Government of Canada in the amount of \$2,050 to return the balance of the grant that cannot be used (instead of \$2,250 as was indicated in the first memo). If desired, a copy of this cheque, once issued, can be provided to you for your records.
