PUBLIC NOTICE

The Council of the City of Toronto proposes to pass a by-law to permanently close a portion of the east limit of Hillside Drive, approximately between 15 Hillside Drive and Gamble Avenue, shown as Parts 1 and 2 on Sketch No. PS-2014-005 and Parts 1 and 2 on Sketch No. PS-2014-006.

At its meeting to be held in the Toronto City Hall on August 12, 2014, commencing at 10:00 a.m., the Toronto and East York Community Council will hear in person or by his or her counsel, agent or solicitor, any person who wishes to speak to this matter.

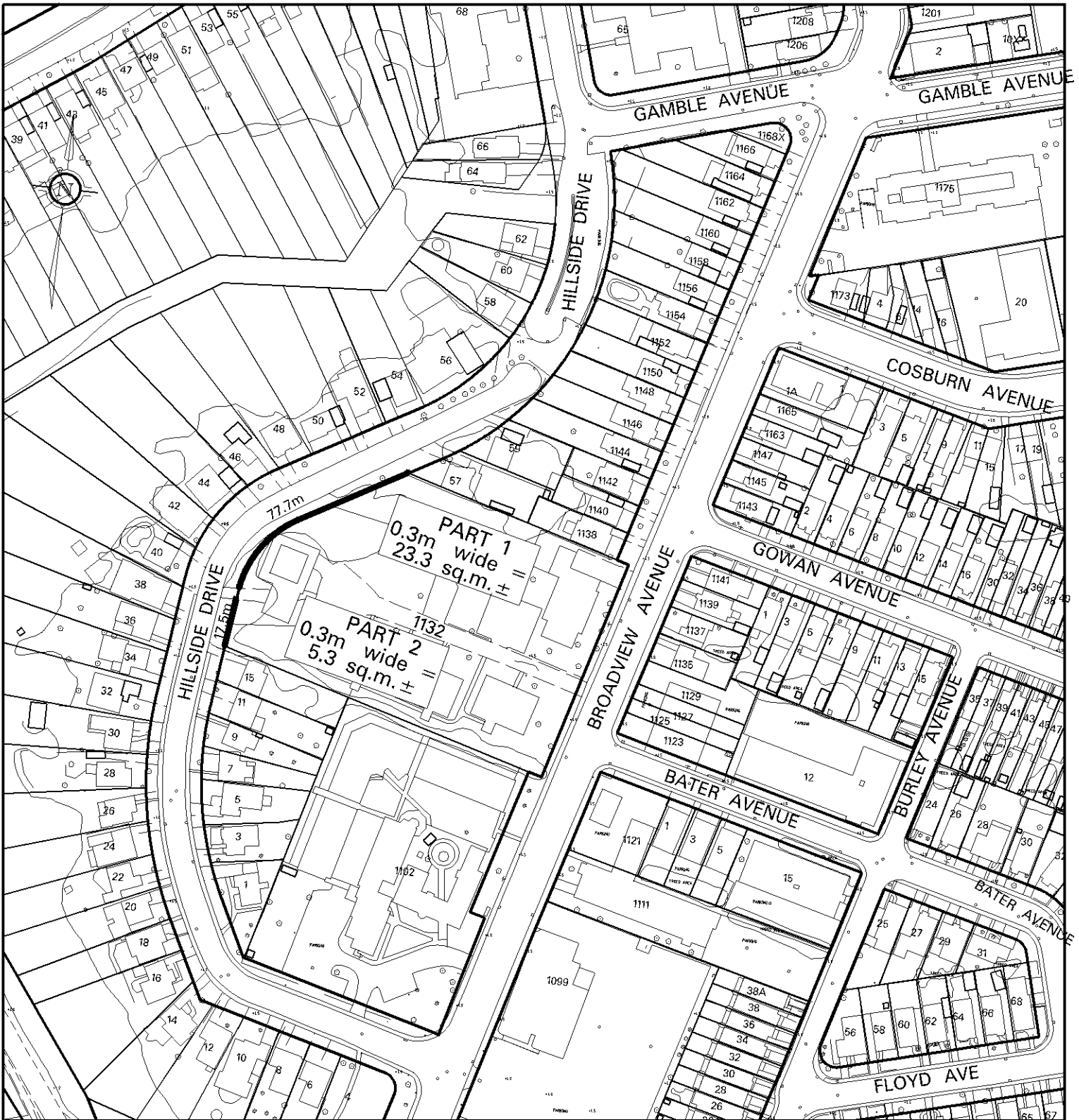
The City videotapes committee and community council meetings. If you make a presentation to a committee or community council, the City will be videotaping you and City staff may make the video tapes available to the public.

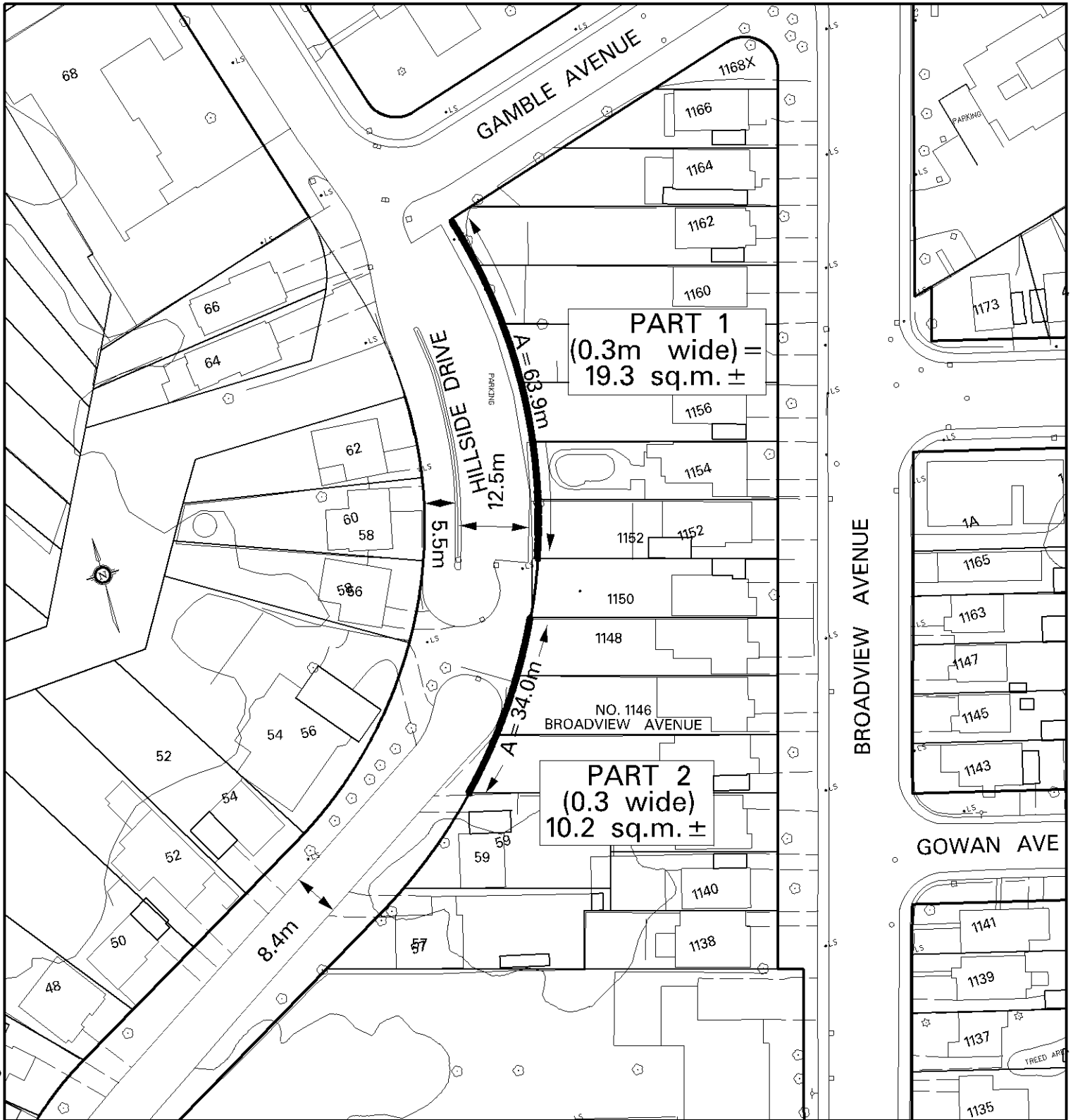
