Thank you for contacting me regarding your proposed trip to Istanbul. As you know, under Article IV of the Code of Conduct for Members of Council, sponsored travel is a recognized exception to the prohibition on members' accepting gifts and benefits.

Based on the following analysis, I conclude that your proposed trip falls within the recognized exception for sponsored travel.

I have reviewed the invitation documents you provided, including the proposed agenda. It appears that your travel will be sponsored by a "conference, seminar, or event organizer", in this case the U.S. Chamber of Commerce in Canada, the Canadian Turkish Business Council, and the Istanbul Chamber of Commerce, and that you will be speaking at an event in your official capacity as Deputy Mayor. Further, I have reviewed the City's lobbyist registry, and these sponsors are not registered lobbyists.

As your travel is estimated to cost more than \$300, please keep in mind that within 30 days of receiving your travel benefit, you will need to file a travel disclosure form with my office, including documents showing the source(s) and cost(s) of your food, lodging, transportation, and entertainment.

In addition, please keep in mind that Article XIII of the Code of Conduct and the City's Lobbying Bylaw (Chapter 140 of the City's Municipal Code) will continue to apply during your trip. Accordingly, you should not engage in communication with any person regarding the matters defined in the lobbying bylaw who is not registered as a lobbyist.
