This form will be posted on the internet as part of the routine disclosure of Councillor office expenses. Forms are to be completed by all donors of cash or in-kind to Council Member-Organized Community Events, irrespective of dollar value. All donations in cash or in-kind will be treated as part of the annual \$10,000 limit. All donations will be accounted for in the calendar year in which it is received.

Income tax receipts shall be issued for donations of \$10.00 or more if requested. For donations in-kind, income tax receipts shall be issued if the gift provides a benefit to the City and is of a non-consumable nature. Donations in-kind of a consumable nature will not qualify for an income tax receipt.

For donations in cash or in-kind that exceed \$300 this form will also act as a Gifts and Benefits Form Report for the Integrity Commissioner and will be provided to the Integrity Commissioner.

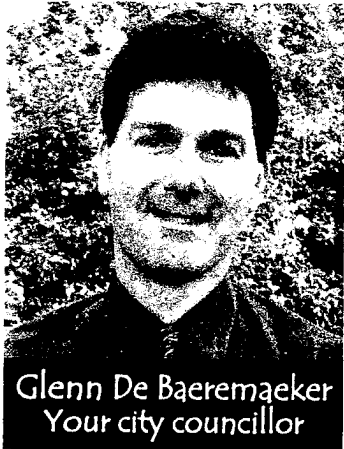
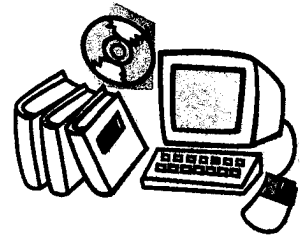

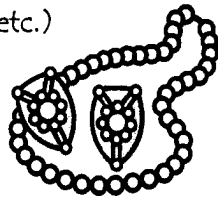

Donate to Goodwill for reuse*

- ◊ Medical equipment (eyeglasses, wheelchairs, walking aids, hearing aids, etc.)
- ◊ Small items (dishes, ornaments, games, etc.)
- ◊ Clothing and linens in good condition
- ◊ Non-perishable food (to be given to a food bank)
- ◊ Books (except school text books)
- ◊ Sporting goods (skates, bikes, rackets, etc.)

Donate to local schools for reuse* (Please keep separate from items above)

- ◊ Costume jewelry, old/broken watches and clocks, and dress-up clothing (costumes, etc.)
- ◊ Art supplies (markers, crayons, etc.)
- ◊ CDs, LPs and children's books
- ◊ Clipboards and corkboards
- ◊ 35 mm cameras/equipment
- ◊ Buttons, keys, fabric and yarn



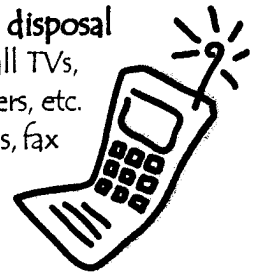
***Donated items in very good condition, please!**

Pick up for FREE

- ◊ Green and Kitchen Bins (with proof of new residency in last 90 days or in exchange for broken bins)
- ◊ Compost for your garden (bring a bin and shovel)

Drop off for recycling or safe disposal

- ◊ Phones, cameras, stereos, small TVs, pagers, radios, VCRs, DVD players, etc.
- ◊ Computers, printers, cartridges, fax machines, laptops, desktops, handheld portables, etc.
- ◊ Hazardous household waste (old medication, cleaning supplies, solvents, motor oil, paint, batteries, pesticides, mercury thermometers, fluorescent bulbs, propane tanks, etc.)



Note: Plastic shopping bags, styrofoam, empty paint cans and empty aerosol cans belong in your Blue Bin – so no need to bring them to this event!
