Personal information contained on this form is collected under the authority of sections 267, 270, 271, 366, 370, and 376 of the *City of Toronto Act*, 2006, and will be used for the proper administration and enforcement of the City of Toronto Municipal Land Transfer Tax, including but not limited to: (a) the collection and maintenance of a record related to the administration of the tax which is available to the general public, and (b) the determination of tax owed including determinations of eligibility for a rebate or refund of the City of Toronto Municipal Land Transfer Tax. ### Information

**Municipal Land Transfer Tax** means the tax imposed by City of Toronto Municipal Land Transfer Tax By-law (By-law No. 1423-2007), as amended.

# When do you need to complete this form?

If you want the City of Toronto to change your address for service for a Municipal Land Transfer Tax matter, the City needs your authorization. You can do this by completing Parts 1, 2 and 5 of this form.

Tax information is confidential. If you want the City of Toronto to deal with another entity or individual (such as your spouse, accountant or solicitor) as your representative for Municipal Land Transfer Tax matters, the City of Toronto needs your authorization. You can do this by completing Parts 1, 2, 3, and 5 of this form.

Your authorization will remain in effect until you cancel it. It is important that you remember each authorization given to the City of Toronto for a Municipal Land Transfer Tax matter so that you can cancel the authorization when it is no longer needed. You can cancel an existing authorization by completing Parts 1, 2, 4, and 5 of this form. All authorizations are automatically cancelled upon notification of death.

You will have to complete a new form if you want to change any information about an existing representative. For example, if your representative is a firm, you may authorize the City of Toronto to deal with a specific individual from that firm. In the future, should you want to replace that individual with another individual from the same firm, you will have to complete a new form to update your authorization.

You can have more than one representative authorized at the same time. However, you have to complete a separate form for each representative.

**Note**: If your representative is a firm and you do not identify a specific individual in the firm as your representative, you are giving the City of Toronto authority to deal with anyone from that firm.

# Does your spouse, common-law partner, or other family member need your authorization?

Yes. The City of Toronto cannot deal with your spouse, common-law partner, son, daughter, or other family member without your authorization.

# What will your representative be allowed to do?

When you authorize the City of Toronto to deal with a representative, you are allowing that individual or entity to act on your behalf in connection with the Municipal Land Transfer Tax matter specified. For example, the representative will be allowed to discuss your confidential

Municipal Land Transfer Tax information with representatives of the City of Toronto and the City of Toronto may communicate with your representative. Should you wish to authorize your representative to represent you only for specific purposes, you will need to specify which purposes in Part 3.

### What happens if you do not sign this form?

To protect the confidentiality of your Municipal Land Transfer Tax information, the City of Toronto will not accept or act on any information given on this form unless you have signed the form.
