# TORONTO LICENSING TRIBUNAL: October 27, 2016 Summary of Decisions C. Paluch / A.N. Alibhai / D. Simon

Samuel Sunny Anike (Report No. 6558)
 Holder of Taxicab Driver's Licence No. D01-3959737

#### **DECISION:**

Samuel Sunny Anike's taxicab driver's licence (No. D01-3959737) shall be immediately suspended and the matter shall be adjourned until such time as the criminal proceedings of Mr. Anike have been definitively disposed of by Court of Competent Jurisdiction.
