# TORONTO LICENSING TRIBUNAL: November 3, 2016 Summary of Decisions A. Walsh / A.N. Alibhai

**1. Sulakshan Selvasingam** (Report No. 6598) Applicant for a Tow Truck Driver's Licence (Application No. B647733)

### **DECISION:**

The Tribunal denied Sulakshan Selvasingam's application (No. B647733) for a tow truck driver's licence.

#### **DECISION:**

The Tribunal adjourned this matter sine die.

**3. Sayed Tamem Hashimi** (Report No. 6696) Applicant for a Tow Truck Driver's Licence (Application No. B657193)

#### **DECISION:**

The Tribunal approved the following jointly Proposed Resolution, with amendments:

Sayed Tamem Hashimi's tow truck driver's licence will be issued, effective immediately, subject to the following conditions:

 All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application/licence will be cancelled;

- (2) Mr. Hashimi must provide to Municipal Licensing and Standards proof of payment of any outstanding fines;
- (3) Immediately upon being issued, the licence will be placed on probation for a period of three (3) years to commence on November 3, 2016;
- (4) During the first year of the probationary period, Mr. Hashimi must provide to Municipal Licensing and Standards, at his own expense, an original updated abstract of his driving record every three (3) months, as accordingly: February 9, 2017, May 11, 2017, August 10, 2017 and November 9, 2017. During the second year of the probationary period, Mr. Hashimi must provide an original updated abstract of his driving record every six (6) months accordingly: May 10, 2018 and November 9, 2018; and during the third year, on November 9, 2019;
- (5) During the three (3) years of the probationary period, Mr. Hashimi must provide to Municipal Licensing and Standards an original updated abstract of his criminal record upon each renewal;
- (6) Mr. Hashimi must attend and pass a third party defensive driving course for a minimum of two (2) days, at his own expense, prior to the issuance of the licence; and present a certificate of completion to Municipal Licensing and Standards;
- (7) During the probationary period, if Mr. Hashimi incurs any new charges and/or convictions under the *Toronto Municipal Code*, the *Criminal Code* or the *Highway Traffic Act*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days. The notification shall include his ML&S licence number and the ticket number(s). Mr. Hashimi can notify Municipal Licensing and Standards in one of the following ways:

- (8) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 6696, and any updating material, shall be brought back before the Tribunal for a full hearing.
