Summary of Decisions

- 1. Antonio Brito Bento** (Report No. 6332)
Holder of Taxicab Driver (Vehicle-For-Hire) Licence No. D01-3843627

DECISION:

The Tribunal approved the following joint Proposed Resolution:

Antonio Brito Bento's taxicab driver (Vehicle-for-Hire) licence will have the following conditions imposed, effective immediately:

- (1) All fees, documents and/or any outstanding requirements, including a new Work Permit issued by Citizenship and Immigration Canada to Mr. Bento or other documentation issued by Citizenship and Immigration Canada as proof of entitlement to work in Canada must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application/licence will be cancelled;
- (2) The licence shall immediately be suspended for a period of seven (7) days, commencing on the date that this resolution is approved by the Tribunal and the licensee must surrender his taxicab driver's licence and photo card on that date;
- (3) Mr. Bento must also provide to Municipal Licensing and Standards proof of payment of any outstanding by-law fines before the date of the hearing, failing which the licence will be suspended until proof of payment of any outstanding fines is filed.
- (4) The licence will be placed on probation for a period of four (4) years to commence on the date that this proposed resolution is approved by the Tribunal;
- (5) Prior to each of the next four (4) renewals of the licence, Mr. Bento must provide to Municipal Licensing and Standards, at his own expense, an original updated abstract of his driving record;
- (6) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 6332, and any updating material shall be brought back before the Tribunal for a full hearing.
