The Tribunal approved the following jointly proposed resolution:

All applications or renewals where zoning has been approved are subject to the following terms and conditions:

 7-Eleven Canada Inc. shall be issued two retail store (food) licences pursuant to application Nos. B540639 and B542212 which shall be immediately suspended for a period of two (2) days commencing on Sunday, May 1, 2016 at 12:01 a.m. and ending on Tuesday, May 3, 2016 at 12:00 a.m.

- The following licences shall be renewed: B50-4201580, B50-4310855 and B50-4423177; and B68-4310857 and B68-4310866.
- All of 7-Eleven Canada Inc.'s licences listed on page 1 of the Proposed Resolution, including the two issued pursuant to application Nos. B540639 and B542212, shall be subject to the following conditions:
 - (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the applications/licences will be cancelled;
 - (2) 7-Eleven Canada Inc. will submit to Municipal Licensing and Standards, within six (6) months, a Policy or Procedure outlining the steps to be taken in order to have new by-law charges reported to Municipal Licensing and Standards within ten (10) days of issuance;
 - (3) Immediately upon being issued, the licences will be placed on probation for a period of two (2) years to commence on the date of issuance;
 - (4) During the probationary period, if 7-Eleven Canada Inc. incurs any new charges as well as any new convictions under the *Toronto Municipal Code*, it must notify Municipal Licensing and Standards, in writing, within ten (10) business days. The notification shall include their ML&S licence number(s) and the ticket/offence number(s). 7-Eleven Canada Inc. shall notify Municipal Licensing and Standards in one of the following ways:
 - in person at 850 Coxwell Ave, Toronto, Ontario M4C 5R1;

 - (5) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 6508, and any new information, may be brought back before the Tribunal for a full hearing.

Hailu Desta (Report No. 6503)
 Applicant for Renewal of Taxicab Driver's Licence No. D01-4295033

DECISION:

Hailu Desta's taxicab driver's licence shall be immediately suspended pending the outcome of his *Criminal Code* and *Highway Traffic Act* charges, at which time he will need to return to the Tribunal for a full hearing, with the following additional conditions to apply:

- (1) Mr. Desta must immediately surrender to Municipal Licensing and Standards his taxicab driver's licence and photo identification card;
- (2) During the interim suspension period, if Mr. Desta incurs any new charges and/or convictions under the *Highway Traffic Act* or the *Criminal Code*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days. Mr. Desta can notify Municipal Licensing and Standards in one of the following ways:

- (3) During the interim suspension period, if Municipal Licensing and Standards has concerns with any new charges or convictions that Mr. Desta may incur under the *Highway Traffic Act* or the *Criminal Code*, those matters and report No. 6503, and any updating material, shall be brought back before the Tribunal for a full hearing;
- (4) Mr. Desta must notify Municipal Licensing and Standards, in writing, of the disposition of all of his *Highway Traffic Act* and *Criminal Code* charges, within 3 business days, in writing, to Municipal Licensing and Standards, in one of the following ways:
 - in person at 850 Coxwell Ave, Toronto, Ontario M4C 5R1;
 - via regular mail to: 850 Coxwell Ave, Toronto, Ontario M4C 5R1;
 - via email to mlsconditionreporting@toronto.ca; or
 - via fax at 416-392-3102
- (5) If the present facts or circumstances surrounding this matter change during the interim suspension period, Municipal Licensing and Standards or Mr. Desta may request to bring this matter back before the Tribunal. Either Municipal Licensing and Standards or Mr. Desta shall submit notice of such request, on notice to the other party, to bring this matter back to the Tribunal;
