TORONTO LICENSING TRIBUNAL: February 11, 2016 Summary of Decisions L. Marzinotto / A. Alibhai / R. Quan

1. 1877453 Ontario Inc. (Report No. 6346)

o/a Taboo Applicant for Renewal of Eating Establishment Owner's Licence No. B71-4308776 and Adult Entertainment Club Licence No. B31-4202355 AND Karunakar Reddy Palle Applicant for Renewal of Adult Entertainment Club Designated Manager's Licence No. T31-4422749

DECISION:

The Tribunal adjourned this matter to April 7, 2016, on consent. In the interim, all three licences will be suspended and the business will remain closed.

2. Steve Omar Ali (Report No. 6453)

Applicant for a Tow Truck Driver's Licence (Application No. B538741)

DECISION:

The Tribunal approved the jointly proposed resolution:

Steve Omar Ali's licence will be issued, effective immediately, subject to the following conditions:

- All fees required, documents and outstanding clearances must be submitted to the satisfaction of Municipal Licensing and Standards prior to the issuance of the licence(s);
- (2) Immediately upon being issued, the licence will be placed on probation for a period of three (3) years to commence on February 11, 2016;
- (3) Prior to each of the next three renewals of the licence, Mr. Ali must provide to Municipal Licensing and Standards, at his own expense,

updated abstracts of his driving record and criminal record;

- (4) During the probationary period, if Mr. Ali incurs any new charges or convictions under *Toronto Municipal Code*, the *Criminal Code* or the *Highway Traffic Act*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days. The notification shall include his ML&S licence number and the ticket number(s). Mr. Ali can notify Municipal Licensing and Standards in one of the following ways:
 - in person at 850 Coxwell Ave, Toronto, Ontario M4C 5R1;
 - via regular mail to: 850 Coxwell Ave, Toronto, Ontario M4C 5R1;
 - via email to mlsconditionreporting@toronto.ca; or
 - via fax at 416-392-3102
- (5) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 6453, and any updating material, shall be brought back before the Tribunal for a full hearing.
