TORONTO LICENSING TRIBUNAL: October 6, 2016 Summary of Decisions M. Laverty / A.N. Alibhai / H.A. Walsh

1. Homayon Bakhtaryani (Report No. 6351) Holder of Taxicab Driver's Licence No. D01-3134356 (Drivers' List No. 5880)

DECISION:

The Tribunal adjourned this matter to January 5, 2017.

(Mr. Bakhtaryani failed to attend today's hearing).

2. Elwyn Satanowsky (Report No. 6563) Applicant for a Tow Truck Driver's Licence (Application No. B645562)

DECISION:

The Tribunal adjourned this matter to January 12, 2017.

 Spiros Tsakopoulos (Report No. 6465) Applicant for a Master Plumber Licence (Application No. B538724) And Rhino Rooter Ltd. Spiros Tsakopoulos, President Applicant for a Plumbing Contractor's Licence (Application No. B539315)

DECISION:

The Tribunal denied Spiros Tsakopoulos' application No. B538724 for a master plumber licence and application No. B539315 for a plumbing contractor licence.

4. Jahangir Rasheed (Report No. 6584)

Holder of Toronto Taxicab Driver's Licence No. D01-4534278 And Holder of Limousine Driver's Licence No. D05-4431395

DECISION:

The Tribunal adjourned this matter pending the outcome of the criminal charge and approved the following jointly proposed interim conditions:

Jahangir Rasheed will have the following conditions imposed on his Vehiclefor-Hire licence (No. D01-4534278) and on his Limousine driver's licence (No. D05-4431395), effective immediately:

- Mr. Rasheed shall not drive unaccompanied female passengers in his taxicab or limousine and his Vehicle-for-Hire licence and photo identification card shall bear the notation "Jahangir Rasheed is not permitted to drive unaccompanied female passengers";
- (2) Mr. Rasheed shall not allow female passengers to sit in the front seat of his taxicab or limousine, and his Vehicle-for-Hire and photo identification card shall bear the notation "Jahangir Rasheed is not permitted to allow female passengers to sit in the front seat";
- (3) If Mr. Rasheed incurs any new charges or convictions under the *Criminal Code of Canada*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days, which can be done in the following ways:
 - in person at 850 Coxwell Ave, Toronto, Ontario M4C 5R1;
 - via regular mail to: 850 Coxwell Ave, Toronto, Ontario M4C 5R1;
 - via email to <u>mlsconditionreporting@toronto.ca</u>; or
 - via fax at 416-392-3102
- (4) If Mr. Rasheed incurs any new charges under the *Criminal Code of Canada*, Municipal Licensing and Standards reserves the right, prior to the resolution of any outstanding criminal charges, to bring any such new charges and an update to report No. 6584, before the Tribunal for a hearing;
- (5) Mr. Rasheed must notify Municipal Licensing and Standards, in writing, of the disposition of the *Criminal Code* charge outlined in report No. 6584, or any change to his conditions, within three (3) business days, which can be done in the following ways:

- in person at 850 Coxwell Ave, Toronto, Ontario M4C 5R1;

- via fax at 416-392-3102
- (6) At any point prior to the Tribunal's final disposition of this matter, Municipal Licensing and Standards or Mr. Rasheed may seek leave from the Tribunal to amend the conditions imposed on the licence if the present facts or circumstances surrounding this matter change. Either Mr. Rasheed or MLS shall submit notice of such request, on notice to the other party, to bring this matter back before the Tribunal.
