Maurice Francis Williams (Report No. 6496)

DECISION:

The Tribunal revoked Maurice Francis Williams' tow truck driver's licence No. D09-4294129 effective immediately; and ordered that Mr. Williams' be advised by registered mail to surrender his licence and photo card within thirty (30) days.

2. Island Hot and Spicy Restaurant Inc. (Report No. 6539)

back before the Tribunal for a full hearing.

DECISION:

The Tribunal approved the following jointly proposed resolution:

Mortaza Auto Clinic Inc., operating as Mortaza Auto Clinic, shall be issued a public garage licence subject to the following conditions:

- (1) The licence will be immediately placed on probation for a period of one (1) year to commence on February 25, 2016;
- (2) During the probationary period, if Mortaza Auto Clinic Inc., operating as Mortaza Auto Clinic, or Mohammed Omar Alemi, incur any new charges or convictions under the *Toronto Municipal Code* or the *Criminal Code*, they must notify Municipal Licensing and Standards, in writing, within three (3) business days, which can be done in the following ways:
