The Tribunal approved the following Proposed Resolution dated July 7, 2017 and signed July 13, 2017:

The Parties agree that during the period from October 21, 2015 to May 14, 2016, the business located at Unit 34, 1300 Finch Avenue West operating as Summer Spa, holding Holistic Centre Licence No. B30-4419275 in the name of Kwan Ling Jackqueline Cheng, was at times operating as a Body Rub Parlour for which it did not hold a licence and that it posted advertisements designed to appeal to erotic or sexual appetites or inclinations.

The parties further agree to the following:

- Jackqueline Holdings Ltd. will be issued a Holistic Centre Licence and Kwan Ling Jackqueline Cheng's Holistic Practitioner's Licence will be renewed;
- (2) Immediately upon being issued or renewed, the licences shall be placed on probation for a period of three years;
- (3) Jackqueline Holdings Ltd. and Kwang Ling Jackqueline Cheng shall ensure that the website http://www.summerspa.ca and all advertisements or websites related to Summer Spa in any other forum or location are immediately removed;
- (4) Jackqueline Holdings Ltd. and Kwan Ling Jackqueline Cheng shall ensure that all advertisements related to the holistic centre operated by Jackqueline Holdings Ltd. are consistent with the professional nature of holistic centre and are not designed to appeal to erotic or sexual appetites or inclinations;
- (5) Kwan Ling Jackqueline Cheng shall provide all holistic services related to the modality or modalities for which she is certified by the professional holistic association to which she belongs and which are consistent with the list of services filed with Municipal Licensing and Standards; and:
- (6) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Jackqueline
