**TORONTO LICENSING TRIBUNAL: June 8, 2016**  
**Summary of Decisions**

- 1. Owais Anwar Ali Ladhiwala** (Report No. 6578)  
Applicant for a Taxicab Driver's Licence (Application No. B542777)

**DECISION:**

The Tribunal approved the following jointly proposed resolution:

Owais Anwar Ali Ladhiwala's licence will be issued, effective immediately, subject to the following conditions:

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application will be cancelled;
- (2) Mr. Ladhiwala must provide to Municipal Licensing and Standards proof of payment of any outstanding fines;
- (3) Immediately upon being issued, the licence will be placed on probation for a period of two (2) years to commence on June 8, 2016;
- (4) Prior to each of the next two (2) renewals of the licence, Mr. Ladhiwala must provide to Municipal Licensing and Standards, at his own expense, an original updated abstract of his criminal record;
