TORONTO LICENSING TRIBUNAL: May 19, 2016 Summary of Decisions A.N. Alibhai / M. Calderwood

1. Bhupinder Singh (Report No. 6544)

Applicant for a Taxicab Driver's Licence (Application No. B538384)

DECISION:

The Tribunal approved the following proposed joint submission:

Bhupinder Singh's licence will be issued, effective immediately, subject to the following conditions:

- (1) Before being issued Mr. Singh must pay the licensing fee of \$229.39;
- (2) Immediately upon being issued, the licence will be suspended until June 30, 2017;
- (3) The licence will be placed on probation for a period of three (3) years to commence on May 19, 2016;
- (4) Prior to each of the next three renewals of the licence, Mr. Singh must provide to Municipal Licensing and Standards, at his own expense, updated abstracts of his criminal record check on an annual basis; and an updated abstract of his driving record check on a quarterly basis for the first year as follows:
 - i) August 18, 2016
 - ii) November 17, 2016
 - iii) February 16, 2017 and
 - iv) May 18, 2017

and annually thereafter for the two remaining years;

- (5) Prior to the completion of the suspension period, Mr. Singh must undertake a two (2) day defensive driving course and submit proof to Municipal Licensing and Standards on or before June 30, 2017.
- (6) During the probationary period, if Mr. Singh incurs any new charges or convictions under the *Toronto Municipal Code*, the *Criminal Code* or the *Highway Traffic Act*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days. The notification shall include his ML&S licence number and the ticket number(s). Mr. Singh can notify Municipal Licensing and Standards in one of the following ways:
 - in person at 850 Coxwell Ave, Toronto, Ontario M4C 5R1;
 - via regular mail to: 850 Coxwell Ave, Toronto, Ontario M4C 5R1;

- via fax at 416-392-3102
- (7) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 6544, and any updating material, shall be brought back before the Tribunal for a full hearing.
