# TORONTO LICENSING TRIBUNAL: June 2, 2016 Summary of Decisions A. Walsh / M. Calderwood / C. Paluch

1. Abdul Wakil Omarzadah (Report No. 6587)

Holder of Toronto Taxicab Owner's Licence No. V00-4532018 for Taxicab Plate No. 4397

#### **DECISION:**

Abdul Wakil Omarzadah will have the following proposed interim conditions imposed on his Toronto taxicab owner's licence, effective immediately:

- (1) Mr. Omarzadah shall not drive a taxicab and transport passengers for hire in the City of Toronto unless the vehicle is equipped with an in-car camera; and he is not to enter any fares' residences;
- (2) If Mr. Omarzadah chooses to have other licensed taxicab drivers drive his taxicab, bearing plate No. 4397, he must keep a log confirming the driver name, date, pick-up time, and drop-off time for each shift; and such log must be made available to Municipal Licensing and Standards upon request;
- (3) If Mr. Omarzadah incurs any new charges or convictions under the *Criminal Code of Canada*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days, which can be done in one of the following ways:
  - in person at 850 Coxwell Ave, Toronto, Ontario M4C 5R1;
  - via regular mail to: 850 Coxwell Ave, Toronto, Ontario M4C 5R1;
  - via email to mlsconditionreporting@toronto.ca; or
  - via fax at 416-392-3102
- (4) If Mr. Omarzadah incurs any new charges under the Criminal Code of Canada, Municipal Licensing and Standards reserves the right, prior to the resolution of any outstanding criminal charges, to bring any such new charges and an update to report No. 6587 before the Tribunal for a hearing;
- (5) Mr. Omarzadah must notify Municipal Licensing and Standards, in writing, of the disposition of the current sexual assault charge or any change to his bail conditions within three (3) business days, which can be done in one of the following ways:

- (6) At any point prior to the Tribunal's final disposition of this matter, Municipal Licensing and Standards or Mr. Omarzadah may seek leave from the Tribunal to amend the conditions imposed on the licence if the present facts or circumstances surrounding this matter change. The party requesting leave must serve notice of such request on the other party.
