TORONTO LICENSING TRIBUNAL: August 16, 2016 Summary of Decisions A.N. Alibhai / M. Laverty / A. Walsh

1. Jeffrey Frederick Merkel (Report No. 6606)

Applicant for a Non-Motorized Refreshment Vehicle Owner's Licence (Application No. B648413)

DECISION:

The Tribunal adjourned this matter sine die subject to the availability of all parties.

(Mr. Merkel did not attend today's hearing).

2. Emmanuel Tetteh (Report No. 6021)

Applicant for Renewal of Taxicab Owner's Licence No. V02-3370106 for Ambassador Plate No. A977

DECISION:

The Tribunal approved the following revised jointly proposed resolution:

Mr. Emmanuel Tetteh's taxicab owner's licence will be renewed, effective immediately, subject to the following conditions:

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application/licence will be cancelled:
- (2) Mr. Tetteh must provide to Municipal Licensing and Standards proof of payment of any outstanding bylaw fines before the date of the hearing, failing which the licence will be suspended until proof of payment of any outstanding fines is filed;
- (3) Immediately upon being renewed, the licence will be placed on probation for a period of three (3) years to commence on August 16, 2016;

- (4) Prior to each of the next three (3) renewals of the licence, Mr. Tetteh must provide to Municipal Licensing and Standards, at his own expense, an original updated abstract of both his driving record and criminal record;
- (5) During the three (3) year probation, Mr. Tetteh must submit to Municipal Licensing and Standards on a monthly basis, for the first year, a doctor's letter indicating Mr. Tetteh is still on his medication and is not a danger to the public and is fit to drive a 'cab'. During the remaining two years the letter is to be submitted every two months;
- (6) During the probationary period, if Mr. Tetteh incurs any new charges and/or convictions under the *Toronto Municipal Code*, the *Criminal Code* or the *Highway Traffic Act*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days. The notification shall include his ML&S licence number and the ticket number(s). Mr. Tetteh can notify Municipal Licensing and Standards in one of the following ways:
 - in person at 850 Coxwell Ave, Toronto, Ontario M4C 5R1;

 - via fax at 416-392-3102
- (7) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 6201, and any updating material, shall be brought back before the Tribunal for a full hearing.

The Tribunal further ordered Mr. Tetteh to submit the original signed letter from the physician by regular mail or in person to 850 Coxwell Ave, Toronto, ON M4C 5R1.
