# TORONTO LICENSING TRIBUNAL: January 7, 2016 Summary of Decisions A. Alibhai / M. Calderwood / A. Walsh

1. Ryan Serge Labelle (Report No. 6506)

Applicant for a Tow Truck Driver's Licence (Application No. B541582)

## **DECISION:**

The Tribunal approved the following jointly proposed resolution:

Ryan Serge Labelle's licence will be issued, effective immediately, subject to the following conditions:

- (1) Immediately upon being issued, the licence will be placed on probation for a period of three (3) years to commence on January 7, 2016;
- (2) Prior to each of the next three renewals of the licence, Mr. Labelle must provide to Municipal Licensing and Standards, at his own expense, updated abstracts of his driving record and criminal record check;
- (3) During the probationary period, if Mr. Labelle incurs any new charges or convictions under the *Toronto Municipal Code*, the *Criminal Code*, the *Highway Traffic Act* or the *Compulsory Automobile Insurance Act*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days. The notification shall include his ML&S licence number and the ticket number(s). Mr. Labelle can notify Municipal Licensing and Standards in one of the following ways:

## **DECISION:**

- (1) Immediately upon being issued, the licence will be placed on probation for a period of four (4) years to commence on January 7, 2016;
- (2) Prior to each of the next four renewals of the licence, Ms. Mary Ann Batac and Ms. Janilyn Batac must provide to Municipal Licensing and Standards, at their own expense, an updated abstract of their criminal record check;
- (3) During the probationary period, if Ms. Mary Ann Batac or Ms. Janilyn Batac incur any new charges or convictions under the *Toronto Municipal Code*, the *Criminal Code* or any other legislation, they must notify Municipal Licensing and Standards, in writing, within three (3) business days.
